- 3. The applicant should submit the employer's certification for the work experience listed in Table 1 of Part I, other supporting documents or statutory declaration to the registration office. However, if the applicant is certified as a member of an authorised trade union for a period of not less than 10 years for application as senior worker, it is not necessary to submit the direct employer's certification.

If the applicant fails to obtain employer's certification for the work experience listed in Table 1, he / she is required to state the reasons of such and provide the contact details of his / her employer in item (9) to (12) of Table 2. The Registrar / trade union (if applicable) may contact the applicant's employer and make any enquiry necessary for processing the application.
