Research Specialist – Construction Innovative Technology

The applicant must possess

- (1) a recognised degree, preferably with post-graduate qualifications in engineering / surveying / architecture / science or other construction relevant disciplines. The post-graduate studies preferably be related to construction innovations in the areas of Lean Construction / Design for Manufacture and Assembly / New Materials Solutions / Robotic or other Automation Solutions / Information Technology / Big Data Analytics Solutions or related disciplines;
- (2) a minimum of 10 years post-qualification work experience in engineering / surveying / architecture / science / research or other construction related fields, with relevant exposure to construction innovative technologies and proven success of promoting the implementation of such in the construction industry is an advantage;
- (3) a high level of integrity and a sense of responsibility;
- (4) good networking capabilities and be able to establish strong working relationships with government, the construction industry and other major stakeholders with the view of encouraging the industry to adopt best practices;
- (5) excellent organisation skills, proactive working attitude and strong interpersonal and communication skills; and
- (6) good command of both written and spoken English and Chinese;

(Applicants who do not possess the required qualifications and / or experience may be considered for other positions within the organisation.)

Duties include

The incumbent is expected to assist the Senior Manager – Construction Innovative Technology in the development of Construction Innovative Technology including:

- (1) to take up the research duties and carry out research projects funded by CIC with the initiatives for enhancing the performance and competitiveness of the construction industry including preparation of work plans, study briefs, research reports and papers, guidelines and standards, documents of technical nature as well as any other relevant documents;
- (2) to assist in the set-up of the Construction Innovation and Technology Application Centre (ITC) and to support and administer the daily operation of ITC once it is put into operation;
- (3) to support the liaison with the government departments and industry stakeholders for the promulgation and implementation of research outcomes, with a view to encourage the adoption of new technology and innovative ideas to enhance the development of the industry;
- (4) to provide secretarial and support to the Management Board on Construction Innovation and Technology Application Centre and to assist in the implementation for decisions and recommendations of the Management Board;
- (5) to provide support to the CIC, its committees and task forces in undertaking research assignments; and
- (6) to carry out any other duties as assigned from time to time by CIC.
