## The applicant must possess

- a recognised degree in civil engineering, building services, electrical or mechanical engineering, quantity surveying or other construction-related disciplines; previous law enforcement experiences or legal background will be an advantage;
- (2) a minimum of 5 years' post-qualification experience in supervising and engaging in construction works on construction sites;
- (3) sound knowledge in trade skills and construction practice in the construction industry of Hong Kong;
- (4) independent thinking and with a high level of integrity and a good sense of responsibility;
- (5) proven track record as a team leader;
- (6) good command of both written and spoken English and Chinese and proficiency in Microsoft application software and Chinese Word Processing; and
- (7) a valid Hong Kong Driving Licence (Class 1 is preferred).

(Applicants who do not possess the required qualifications and / or experience may be considered for other positions within the organisation.)

## **Duties include**

Report to the Manager - Inspection & Enforcement, the incumbent is expected:

 to enforce the Construction Workers Registration Ordinance Cap.583 ("CWRO"), including daily construction site inspection, daily attendance record checking and prosecution where appropriate; work on weekend is occasionally required on a roster basis;

- to investigate, gather evidence, take witness statements, file summons and prosecute in court for cases non-compliant to the CWRO;
- (3) to lead inspectors to execute inspection plan with high quality and integrity as well as full compliance to the policies and procedures;
- (4) to prepare inspection plan, inspection case analysis and bilingual reports;
- (5) to keep abreast of the trade skills development and the latest practices in the construction industry; continuous learning is required;
- (6) to assist to oversee the operations of the Inspection and Enforcement Team including addressing enquiries, conducting CWRO briefings and various reporting; and
- (7) to carry out any other duties as assigned from time to time by the Executive Director.

The position is on a renewable fixed-term contract (subject to performance and operational needs) for a period of 2 years.
