# **Objectives**

Hong Kong's new *Competition Ordinance* applies to businesses in all sectors of the economy, including construction industry clients, contractors and subcontractors. The Construction Industry Council (CIC) has established a Task Force on Competition Law to undertake various tasks on aspects of Competition Law in relation to the construction industry for the benefits of industry stakeholders.

The *Competition Ordinance* aims to uphold the competitive process. Two "conduct rules" prohibit any person or company from behaving in a way that prevents, restricts or distorts competition in Hong Kong. Three months since the full enactment of the *Competition Ordinance*, the CIC is organising this seminar to update industry stakeholders on the latest development in these areas:

- 1. General outline of the Competition Ordinance and introduction to CIC's reference materials,
- 2. Leniency and bid-rigging, and
- 3. Development since the law came into effect.

## <u>Remarks</u>

- 1. The Technical Seminar will be conducted in **<u>English</u>**.
- 2. It is suggested that participation in the Technical Seminar counts for <u>2.5</u> CPD hours.
