Guidelines on Partnering

The Contracts (Rights of Third Parties) Ordinance Cap 623 is in effect since 1 January 2016. The Ordinance will apply to construction contracts entered into after the commencement date. Legal expert will provide an overview of the ordinance and how it would affect the operations in the construction industry.
