the comments provided by the Hong Kong Institute of Surveyor (HKIS). In response to the comments of the HKIS, Members agreed to change the title of the Guideline by deleting "Security of Payment" to properly reflect the main subject of the Guidelines. Members suggested defining clearly in the Guidelines the role of the Independent Expert Certifier which should only be involved at the time of disagreement or disputes, but not replacing the role of Architect / Engineer / QS in daily certification process. Members also suggested revisiting the Guidelines to ensure the roles of other proposed entities involved in dispute resolutions being clearly defined. The Secretariat would revise the Guideline per Members' comments before submitting to the Council.

## 4.4 **Protection of Workers' Entitlement to Wage Payment**

Members took note of the Paper CIC/SBC/P/016/09 and discussed the comments provided by Hong Kong Federation of Electrical and Mechanical Contractors (HKFEMC). After considering carefully the feasibility in actual implementation of the measures in private sector projects, Members agreed to amend or clarify a number of clauses in the Guidelines. Measures related to biometric authentication and MPF were considered not appropriate to be incorporated in the Guidelines and would be taken out as suggested by Members at the meeting. The Secretariat would revise the Guidelines according to Members' comments and submit to the Council for discussion.
