CIC has launched a voluntary and HK-based Carbon Labelling Scheme for Construction Products, with a focus on the impact of climate change. The scheme covers Cement, Reinforcing bar, Structural Steel product, and now also Ready-mixed Concrete. The Carbon Labelling Scheme aims to provide verifiable and accurate information on the carbon footprint of construction products for users to make informed decisions and reduce the carbon footprint of a construction facility. An upcoming Awareness Training Course will be held on 4 December 2014.
