
建造業議會發表新指引

In January 2012, the CIC published the "Guidelines on Safety of Lift Shaft Works (Volume 2 - During Lift

Installation Stage until Issue of Occupation Permit and Handing Over to Developer)". The Guidelines set out the good practices recommended by the CIC for enhancing occupational safety of site personnel working inside or near lift shafts during lift installation stage until issue of Occupation Permit and handing over to developer.

It is hoped that the Guidelines can stimulate the whole

construction industry to adopt safety precautionary measures for lift installation works.

February 2012. The Seminar served as a sequel to the "Guidelines on Handling Construction Work Injury and Fatal Accident Cases" published in July 2011.

The Seminar was well received by over 200 industry stakeholders. It is believed that the Guidelines and the Seminar will provide guidance on the whole injury compensation process, including the adoption of mediation, to facilitate workers and employers to rights understand their and obligations.

The NEC 3 (New Engineering Contract 3) is a suite of construction contracts promoting contractual partnering and is designed to meet of various project needs three arrangements with key namely: objectives, flexibility, simplicity and clarity, and provide stimulus for good project management.

To enhance its awareness and encourage sharing of experience, the CIC conducted a technical forum on the topic of "NEC3 Collaborative Contracts" on 7 March 2012. The industry responded fervently with over 210 practitioners attended.

A Talk on Corruption Prevention for Subcontractors with Illustrated Cases and Regulatory Actions under VSRS - 16 March 2012 非強制性分包商註冊制度規管行動及防貪教育講座 — 2012年3月16日

The CIC invited the Hong Kong Independent Commission Against Corruption (ICAC) to jointly deliver "A Talk on Corruption Prevention for Subcontractors with Illustrated Cases and Regulatory Actions under VSRS" on 16 March 2012, strengthen subcontractors' knowledge on corruption prevention. The Talk attracted the participation of over 50 industry practitioners.

Representatives of the ICAC briefed the attendees on the recent trends of corruption cases and the legal provisions if in breach of the Prevention of Bribery Ordinance with advices on precautionary measures. Mr. TSE Chun-yuen, a member of the

Management Committe of VSRS introduced the regulatory regimes under the voluntary subcontractor registration system for the attendees on behalf of the CIC. It is expected that the talk will help participants to have a better understanding of corruption prevention and promote an ethical culture within the industry.

Technical Seminar on Contract Price Fluctuation System (CPFS) - 21 March 2012 合約價格調整制度技術研討會 ── 2012年3月21日

It is agreed that CPFS would be an effective mechanism to reduce the pricing risk for contractors and rationalise the construction cost for employers in the long-run. It is hoped that the Guidelines and the Seminar will help cultivate a more harmonious working environment and the quality of projects will be improved through the adoption of CPFS.



What Accreditation Offers to the Construction Industry?

Accreditation and its advantages

Accreditation is the third-party attestation that conformity assessment bodies (including testing laboratories, inspection bodies and certification bodies) are in compliance with relevant international standards and technically competent to perform specified activities. In Hong Kong, accreditation is open and voluntary. Hong Kong Accreditation Service (HKAS) of the Innovation and Technology Commission provides accreditation for local laboratories through the Hong Kong Laboratory Accreditation Scheme (HOKLAS). The aims of HOKLAS are to upgrade the standard of testing and management of the laboratories; to identify and officially recognise competent testing and calibration laboratories; and to promote the acceptance of test results and calibration certificates from accredited laboratories both locally and internationally.

The benefit of accreditation is to give assurance on the reliability of testing and calibration services. There are about 200 accredited organisations in Hong Kong, providing such accredited services industries. for various 50 construction Around material testing laboratories accredited. To the construction materials testing trade, accreditation has a long history of over 25 years, the first construction laboratory was accredited by HKAS in 1986. To demonstrate the compliance of construction materials used in construction projects met with the standard contract requirements of works departments of HKSAR government, test reports from a HKAS accredited laboratory are often accepted as evidence of compliance. Throughout the years, construction industry in Hong Kong has built up its reputation in building skyscrapers; and various memorable features such as our world-class international airport and our Tsing Ma suspension bridge. HKAS

is proud to contribute to the reliance of the testing services provided by our accredited laboratories.

Enhanced reliability of site testing offered by accredited laboratories

Part of the services provided by our accredited laboratories occurred at construction sites. It is important that reliable

CONTRO services of quality acceptable are provided not only in the laboratory, but also at construction sites where much work relied on the site operators. HKAS had issued some additional requirements to strengthen the site supervision and tighten the control in construction materials testing. These additional requirements addressing the high risk areas had been developed by HKAS through

close liaison with the accredited laboratories and other stakeholders. They aim to maintain the confidence on quality of site testing carried out at construction sites and have been implemented since December 2009. These additional requirements are applicable to test areas where tightened site supervision is desirable and beneficial to the output quality. Those areas include concrete cube tests, steel reinforcement bar tests, non-destructive tests on welds and site tests such as sand replacement tests and anchor bolt proof load tests. Requirements on monitoring of work in-take against the laboratory's testing capacity, strengthening of site supervision, provision of secure means of recording test results to prevent falsification and protection of test operators from undue pressure are included. Construction laboratories in general welcomed the additional measures and found no problem in achieving them. Unannounced visits conducted by HKAS to the construction laboratories also confirmed their continuous compliances.

「認可資格」是由第三者正式確認一 間合格評定機構(包括測試實驗所, 檢驗機構及認証機構)有能力進行特 定的合格評定工作。在香港,獲取"認 可資格"屬自願參與性質並公開接受 任何機構申請。而此第三者,亦即 是創新科技署轄下的香港認可 處(HKAS),透過香港實驗所認可計 劃(HOKLAS)發出證明,認可香港實 驗所的測試能力。實驗所認可計劃的 目的在於正式確認有能力的測試及校 正實驗所,從而提升實驗所的測試及 管理水平,並推動本地和國際機構接 納獲認可實驗所發出的測試結果及校 正報告。

「認可資格」的好處是可以確保 實驗所的測試和校準服務的可 靠性。

香港認可處於1986年正式認可第一 間建築材料測試實驗所,至今建築材 料測試的認可歷史已逾25年。現時香 港約有200間獲認可機構為各行各業 提供服務,其中大約50間為建築材料

測試實驗所。獲香 港認可處認可的實 驗所發出的測試報 告經常會被用作證 明建設項目中所使 用的建築材料合乎 香港政府各工務部 門合約的要求。多 年來,香港建造業 興建了無數的摩天 大樓及知名地標, 如世界級的國際機 場和青馬懸索橋, 在國際上享負盛 名。香港認可處對 於能夠確保獲認可 實驗所能提供有質 素的測試服務而感 到驕傲。

而附加要求包括需要 實驗所監察其人手是否能夠應付 所承擔工作量、 又需要實驗所加 強其工地監督、以及提供具安全 性的測試記錄保存系統,以防止 偽造和保障測試操作員免受不適 當的壓力。建築材料檢測實驗所 均普遍表示歡迎這些不難去符合 的額外要求。另外,香港認可處 曾在沒有事先通知下對建築材料 檢測實驗所進行評定訪問,而評 定的結果亦確定它們經常能符合 這些要求。

CIC Welcomes the Continual Support of Government 建造業議會對政府持續的支持表示歡迎

In the 2012-13 Budget, the Financial Secretary earmarked an additional funding of HK\$220 million to support the Construction Industry Council (CIC) to further enhance training for prospective fresh blood and in-service construction personnel in order to meet the anticipated manpower demand for infrastructure development in the future.

CIC welcomes the additional funding of \$220 million from the Government, the which reinforces strong commitment and ensures a firmer foundation for the construction manpower development. Mr. LEE Shing-see, Chairman of the CIC says, "CIC welcomes the measures proposed by Government and will render its full support to cope with the manpower demand construction industry through providing more training places and will facilitate job matching of the graduates through our 'Construction JobsNet'."

Background

In May 2010, the Government sought the approval of Finance Committee of Legislative Council for a \$100 million funding to support the CIC to enhance training and trade testing for prospective fresh blood in-service construction personnel, and to enhance promotion and publicity activities to attract more people to join the industry. Not less than \$80 million is allocated for reimbursing the CIC of training allowances and trade testing and course fees benefiting trainees and workers. The remaining funds will be used to enhance promotion and publicity activities to attract more people to join the construction industry.

CIC launched the Build Up Training Programme in September 2010 by phases, with the following initiatives:-

- a. Enhanced Construction Manpower
 Training Scheme (ECMTS);
- b. Senior Construction Workers Trade
 Management Course;
- c. Subsidy for Trade Test;
- d. Subsidy for Specified Training Course / Skills Enhanced Course;
 and
- e. Enhanced Construction Supervisor
 / Technician Training Programme.

Among 935 trainees enrolled in the ECMTS by end January 2012, nearly 60% are under the age of 35 which reflects that more young people are willing to join the construction industry after the implementation of the Build Up Training Programme. This reflects the initial success of the programme. We had conducted surveys which revealed more respondents considered that the economic outlook of the construction industry was becoming more favourable and the image of the construction workers was positive and healthy.

背景

議會於2010年9月分階段推出「Build 升」計劃,並引入以下措施:

- 強化建造業人力訓練計劃(ECMTS);
- 2. 資深工人之行業管理課程;
- 3. 工藝測試津貼;
- 4. 指明訓練課程津貼 / 技術提升課程津貼; 以及
- 強化建造業監工/技術員培訓課程。

截至2012年1月底,935名參加ECMTS 的學員中,近六成學員的年齡為35歲以 下,這反映了於「Build升」計劃實施 後,有更多年輕人願意加入建造業,同 時亦反映了計劃的初步成功。根據議會 進行的調查,現時更多受訪者認為建造 業的經濟前景變得更有吸引力,而建造 工人的形象為正面和健康。
