		(d) On 21 February 2023, the Secretariat had arranged a meeting between the representatives of RSTCF and HKIC to discuss the optimisation of the "Trade Supervisors" training programme (i.e. Diploma in Construction for Specialist Trade Management).
		(e) The Secretariat will continue to cooperate with trade associations to organise technical webinars for designated trades. The first technical webinar in 2023 covering Building Drainage Installation was held on 9 March with the support of the Hong Kong Plumbing and Sanitary Ware Trade Association. There were totally 828 participants.
		(f) The Secretariat will work with the ICAC to arrange a series of seminars to continuously improving the integrity management of the registered companies. CIC and the ICAC will hold the Construction Industry Corruption Prevention and Integrity Management Summit and Programme of Action Signing Ceremony on 4 May 2023 at the CIC Zero Carbon Park with the theme of "Eliminating Injustice and Sharing Honest Results" to join hands with the industry for creating an incorruptible business environment.
