#### PROGRESS REPORT

#### Action

#### 2.1 Confirmation of the Progress Report of the Committee **Meeting No. 001/10**

Members took note of the Paper CIC/PCM/R/001/10 and approved the progress report of the last meeting held on Monday, 12 April 2010 at Board Room, MTR Headquarters Building.

#### 2.2 **Matters Arising from the Previous Meeting**

#### Agenda item 1.3:

The reply in response to Mr Peter LAM (HKFEMC)'s email was sent via e-mail on 21 June 2010 for record purpose. A coordinated reply to HKIS was formally issued on 21 June 2010.

Regarding invitation to REDA for more participation in this Committee and its task forces, the CIC Chairman decided to issue a letter to REDA by himself to solicit more involvement of REDA in the CIC and its committees. The letter would be issued to REDA on 23 June 2010.

CIC Secretariat would follow up with REDA and arrange a luncheon / an informal meeting specifically for the Com-PCM Secretariat among REDA's relevant members, the Committee Chairman and the two Task Force Chairs.

Regarding the KPI for implementation of the guidelines on partnering in the industry, a meeting had been held with Mr Colin Jesse to discuss this subject.

## 2.3 Presentation on New Engineering Contract (NEC) by British Chamber of Commerce Construction Industry Group and NEC Authorised Trainers

Representatives from British Chamber of Commerce Construction Industry Group and NEC Authorised Trainers delivered a presentation on NEC.

Members had much discussion on the principles and the application of NEC in Hong Kong. There was a general consensus that collaborative partnering approach should be considered for the delivery of complicated project. However, as to the form and type of contract, the Committee might consider to look into NEC in future as a way of collaborative contracting principle.

# 2.4 Presentation on Product Certification by Housing Department

Representative of the Housing Department delivered a presentation on product certification.

It was also reported that the Housing Authority was discussing with the Hong Kong Construction Association on the establishment of a new system, named Voluntary Supplier Management System (VSMS) as a next step in the development of product certification initiative. All domestic suppliers would have to register with the system before it could supply products for Housing Authority's projects.

Mr Christopher To stated that the Commissioner of Innovation and Technology, who was involved in the CIC in the past, would set up a meeting with the Chairman of Committee on Environment and Technology, the CIC Chairman and the Secretary General of Hong Kong Accreditation Service regarding this subject. The results of the meeting would be reported back to the Committee through the CIC Secretariat, if appropriate.

The Committee took note of the issue and its current development. In view that this initiative had been taken forward and under consideration by the CIC Chairman and other industry stakeholders. The Committee would await further direction from the main Council after their discussion.

## 2.5 Progress Report of Meeting No. 002/10 of the Task Force on Contract Price Fluctuation System (CPFS) for Private Sector Construction Contracts

SGN briefed Members on the Paper CIC/PCM/P/007/10 regarding the progress of the Task Force on CPFS for Private Sector Construction Contracts.

<u>Contract Price Fluctuation System (CPFS) for Private Sector</u> Construction Contracts

The revised outline of the Guidelines was agreed. The drafting works had started. Although, the progress of the Task Force (TF) was slightly lagging behind programme, the TF was confident that it could catch up.

#### **IPS/Milestone Payment**

TF members could not reach consensus as to the best or most suitable payment method and the Committee agreed further discussion and the possible guidelines production could be deferred. The task programme would be revised accordingly.

## 2.6 Progress Report of Meeting No. 002/10 of the Task Force on the Selection of Consultants and Contractors & Progress Report of Task Groups meetings

KP presented the Papers CIC/PCM/P/008/10 and CIC/PCM/P/009/10 regarding the progress of the meetings of the Task Force and the Task Groups.

KP reported that each Task Group had met twice since the last Committee meeting in which the current practices and selection criteria were consolidated and summarized, issues and possible solutions were also briefly discussed. The Task Group members were further divided into sub-groups to summarise the deliberations/discussions into a consolidated schedule. The overall progress of the TF was slightly behind compared to the established programme.
