# 2.3 Committee Membership, Terms of Reference and Meeting Rules

Members took note of the Paper CIC/SBC/P/005/10 and agreed to retain the current terms of reference of the Committee. However, consideration could be given to modifying some wording or add new wording to reflect more accurately the tasks of the Committee as and when required.

#### 2.5 Model Documents for Dispute Resolution

Members took note of Paper CIC/SBC/P/007/10.

Members agreed that sample contract clauses setting out alternative dispute resolution methods should be made available for industry stakeholders to incorporate in local construction works contracts. In view of the complexity of the legal documents and associated implications, Members considered it necessary to engage a legal adviser to draft the documents though there might be some budget concerns. The CIC Secretariat was directed to submit a funding request to the Committee on

Administration and Finance and the CIC for further consideration.

Members also agreed to set up a Task Force on Dispute Resolution Documentation to steer the drafting exercise and where necessary, review the timeline for this task. As the sample clauses would draw on the recommended measures in the Guidelines on Dispute Resolution to be published by the CIC, Members would like to invite Ms Teresa CHENG to lead the Task Force.

# 2.6 Report on Survey of Problems of Outstanding Payments in Construction Supply Chain ("Survey Report")

Members took note of Paper CIC/SBC/P/008/10 and agreed that the Survey Report reflected the existence of outstanding payment problems in the construction industry and identified the difficulties perceived by the respondents.

Some Members cast doubt on the reliability of the amounts held up by the upper tiers as reported in the survey findings as they were projected figures based on the perceived survey responses which could deviate significantly from the actual figures.

Though the Survey Report might not be perfect in terms of the response rate of the survey in some of the sectors, Members believed that it could provide a good basis for the CIC to identify suitable measures to help address the outstanding payment problems.

In response to a Member's query, the Public Opinion Programme (POP) of the HKU would be requested to clarify the "frequently used resolution channels" in the public maintenance works as there was a doubt that the appointment of dispute resolution adviser was not the current practice applicable in the public maintenance works.

After deliberation, Members agreed to submit the Survey Report to the CIC for endorsement. Some Members expressed reservation on publishing the rough projected but sensitive figures to the public which would mislead and cause confusion to the public. Some considered prudent for the CIC to formulate responses to the media before publishing the Survey Report at the CIC website. Some suggested the CIC to consider that the Survey Report should be issued to the concerned industry stakeholders for internal reference only.

The Chairman gave a special vote of thanks to Mr Bernard HUI for his leadership to the Task Force on Survey of Problems of Outstanding Payments in Construction Supply Chain.

[Post-meeting notes: The POP checked the actual responses captured from the respondents and confirmed that there were 61 respondents chosen "Dispute Resolution Advisor" as one of the most commonly used resolution channels for the "Pubic Maintenance Works and advised not to amend the figure".]

2.6.1 Subcontractor Management Plan for Public Works

Members received a presentation from the Development Bureau on the framework and key scope of the Subcontractor Management Plan (SMP) adopted in public works projects, supplemented with a summary note tabled at the meeting.

The deliberation on the use of the SMP was deferred till Members were briefed on the next agenda item.

2.6.2 Possible Solutions to Outstanding Payment Problems (Security of Payment – Simple Information Pack)

Members took note of Paper CIC/SBC/P/009/10 and exchanged their views on various payments problems encountered by different stakeholders along the construction supply chain.

Taking into account of the SMP, Members considered that making user-friendly and simple written contracts readily available for adoption by subcontractors could be an effective measure to help minimise payment problems occurred in lower tier subcontracting. As such, a Task Force on Standard Contract Provisions for Domestic Subcontracts would be set up to steer the work. Reference could also be made to the Guidelines on Subcontracting Practice and Guidelines on Standard Forms of Domestic Subcontracts for Basic Trades

Members noted that the registration office of the Voluntary Subcontractor Registration Scheme was situated in Wanchai. Having negotiated with the landlord, the HKCA, the current tenancy agreement would be renewed for 12 months (terminable after the first 6 months) at the same monthly rental upon expiry.
