7.2.7 Discussion of introducing the Enhanced Ethical Status (EES)

Members recalled that the Committee at its meeting held on 7 April 2008 agreed to introduce the EES to the VSRS as an additional requirement for all those registered subcontractors committed to the ethical standards on a voluntary basis. However, given that ICAC only targeted at those parties undertaking building maintenance works, some Members raised that applying the proposal to all subcontractors registered under the VSRS was not the exact intention of ICAC. In addition, such proposal would result in all subcontractors, not just building maintenance subcontractors, being fallen within the ambit of the EES which would cause unnecessary burden on non-building maintenance subcontractors. On the other hand, some Members opined that the alternative proposal of setting up a separate registration scheme for building maintenance subcontractors only was not acceptable as registration schemes administered by CIC should serve the industry as a

whole instead of working for the good of only a particular group of stakeholders. As neither of the proposals could resolve the aforesaid concern, the Committee declined ICAC's proposal of introducing the EES to the VSRS.

7.3 **Security of Payment**

7.3.1 Formation of a Task Force on the Survey of Problems of Outstanding Payments in Construction Supply Chain (Task Force on the Survey)

Members took note of the Paper CIC/SBC/P/025/08 and agreed to form the Task Force on the Survey. A Member requested that the survey should cover main contractors and electrical and mechanical specialist contractors again in view of the recent abrupt changes in the business environment. Members agreed to extend the survey scope Members also made clear that such as requested. extension of the survey scope was not due to any doubt about the survey commissioned by HKCA but aimed to ensure consistence of survey findings and compatibility for analysis in the existing volatile business environment. In case the budget approved by the Committee on Administration and Finance was exceeded. approval for additional budget would be sought.

A Member relayed a subcontractor's concern that the Labour Department conducted inspections on the 8th day after the end of wage period and enquired workers if the subcontractor failed to pay wages to them on time. Subcontractors commented that such acts might break harmonious labour relations. Other Members noted that the Employment Ordinance requires an employer to pay wages to an employee as soon as practicable but in any case not later than 7 days after the end of wage period. As such, the Labour Department only conducted inspections to enforce the wage provisions under the Employment Ordinance and subcontractors should fulfill their statutory obligation to pay wages on time.
