They are: <ul style="list-style-type: none"><li>● Aberdeen Headquarters (WRO-ABD) to remain open on Sundays;</li><li>● All WRO would close on certain Sundays during long weekends or festive holidays (all WRO will close on 30 June and 13 October in 2013. For the years to come, workers Registration Secretariat (WR-Sect) will work together with WRO at year-start to fix the Sundays when registration services will be suspended); and</li><li>● All temporary contract staff would take shifts to work on Sundays and take their compensation leave in the week that follows</li></ul>

If the table is found obsolete, then it has to be revised.</li> </ul>
3.1	CB/2013/25	<p><b><u>Impact of the Private Data (Privacy) Ordinance (Amendment) Ordinance 2012 on Collection of Construction Workers' Data</u></b></p> <ul style="list-style-type: none"> <li>- To enquire the Office of PCPD again if the construction workers data collected by CWRB could be used for dispatching news on registration and renewal.</li> <li>- To send the new personal data collection statement to data subjects whose personal data was collected in the period from 1 April 2013 to the date when the registration application form was revised to get their consent of using their personal data.</li> <li>- In future, personal data of construction workers would be used for renewal reminders only</li> </ul>
3.2	CB/2013/26	<p><b><u>Allowing Construction Workers Who Offend the Construction Workers Registration Ordinance to Plea Guilty by Letter</u></b></p> <ul style="list-style-type: none"> <li>- To seek legal advice on the captioned issue and making the breach of the Ordinance (on workers' part) a fixed penalty offence, and to pass the legal advice sought to DevB to facilitate their negotiation with DoJ.</li> </ul>
