3.1	CIC/CRB/P/017/18 (for information)	<p>Progress Report and Discussion of the Consultancy Services for Workforce Analytics for the Construction Industry of Hong Kong</p> <p>(a) The consultancy service was commenced in June 2018, followed by the establishment of the "Advisory Group" comprising seven key industry stakeholder associations under the Task Force on Data Analysis. Arcadis had substantially completed the review and analysis of current data collection via Construction Workers Registration Gateway and telephone survey. Arcadis had consulted each of the seven key industry stakeholder associations, the Government, and relevant organisations such as VTC in July and August, with preliminary observation shared with Chairman of CWRB and Chairman of Task Force on Data Analysis in August. The consultancy study was expected to be completed by end of January 2019.</p> <p>(b) Arcadis presented the findings to the CWRB. As some workers carry out works at construction sites and locations not subjected to the Construction Workers Registration Ordinance (CWRO) at the same time, data collection will be expanded beyond the scope of CWRO to estimate the number of workers involved in repair, maintenance, alteration and addition works.</p> <p>(c) A structured model will be developed to combine the data collected and the expanded data. Afterwards Arcadis will develop a set of dashboard reports and key performance indicators covering the followings to reflect on the labour situation of the Hong Kong construction industry:</p> <ul style="list-style-type: none"> - Levels of engagement and active workers' definition - Volume of work and seasonality - Horizontal and vertical mobility - Retention and attrition - Future capture of data on obscure segments like RMAA works

A total of 1,753 workers' daily attendance records (DAR) were checked.</p> <p>(b) From January to July 2018, a total of 53 summonses were issued. Among them, 3 summonses were issued in relation to the carrying out of construction work by unregistered construction worker and 50 summonses were issued for failing to submit DAR within the prescribed statutory period.</p>
