# <u>Post-visit Report to Visit to buildingSMART International Standards Summit – Lillestrøm 2023</u>

#### **Purpose**

1.1 This paper presents a post-visit report on the buildingSMART International Standards Summit - Lillestrøm 2023 of a delegation team of Hong Kong AEC professionals and the Construction Industry Council ("CIC").

### **Background**

- 2.1 The CIC received an invitation from the Hong Kong Chapter of buildingSMART to attend the buildingSMART International Standards Summit Lillestrøm 2023. Professor Jack CHENG Chin-pang, Chairperson of the Committee on Building Information Modelling and Construction Digitalisation (Com-BIM & CD), supported the invitation.
- 2.2 Professor Jack CHENG Chin-pang designated two representatives, Ir Dr. George WONG, Senior Manager-Industry Development and Mr. Ion CHAN, Manager-Building Information Modelling from the Construction Digitalisation Department of the CIC to join. Jack and Mr. Kevin WONG Sai-choi, a Member of the Com-BIM & CD also joined the Summit.
- 2.3 The buildingSMART was founded in 1995 and it is a worldwide authority driving the transformation of the built asset economy through creation and adoption of open, international standards. One of their key missions is to promote an open data format in BIM named the Industry Foundation Classes (IFC) format. They believe open sharable asset information will help the supply chain unlock more efficient and collaborative ways of work throughout the entire project and asset lifecycle. Every year, the organisation organises two large-scale events globally and bring together international openBIM community to help refine the standards and services that ensure a more sustainable, productive, and collaborative future for the built asset industry.

- 2.4 The buildingSMART International Standards Summit Lillestrøm 2023 was held at Thon Hotel Arena in Lillestrøm, Norway from 18 to 21 September 2023. The 4-day event specifically focused on digital products and openBIM workflow through Workshops, Masterclass, Award Presentation and Domain Sessions, which are workgroups focused on specific area or context on the development of open solutions and standards.
- 2.5 Two additional side meetings and two side visits were arranged in between and after the Summit to take full advantage of the event. The buildingSMART Regulatory Domain meeting took place on 19 September 2023 and the meeting with buildingSMART International President and CEO was held on 20 September 2023. The visit to Viking Ship Museum project and Catenda office took place on 21 September 2023.
- 2.6 A delegation of 22 Hong Kong construction professionals joined the Summit. In the event of openBIM Awards 2023, there were five Hong Kong teams out of 22 finalists presented during the Summit.

#### The Hong Kong Delegation

- 3.1 Invitation to join the Hong Kong delegation was organised by the Hong Kong Chapter of buildingSMART. A 22-member delegation was formed comprising of Members of the CIC, HKSAR Government departments, Consultants and Contractors.
- 3.2 The following organisations joined the delegation:
  - (a) Water Supplies Department;
  - (b) Planning Department;
  - (c) Hong Kong Alliance of Built Asset & Environment Information Management Associations (HKABAEIMA);
  - (d) The Hong Kong University of Science and Technology;

#### **Highlights and Takeaways**

#### 4.1 International Standards Summit - Lillestrøm 2023 and side visits

#### (a) Highlights

During the 4-day Summit, a total of 48 sessions were conducted including stage presentation, workshops and masterclasses, case studies, panel discussion, etc. Some highlights for the topics or areas our members learnt in the Summits are listed below:

- (i) openBIM and Product Passports;
- (ii) Latest Digital Twins development;

- (iii) Latest openBIM standard development including IDS, openCDE, IFC4.4, IFC5;
- (iv) Latest IFC validation service and openBIM Ecosystem; and
- (v) Latest Innovative BIM use cases in Bridge project, Railway project and projects in Award presentation.

Two of the Hong Kong finalists of the openBIM Awards 2023, Water Supplies Department and China Communications Construction Company Ltd., received Special Mentions -2023.

In addition to the summit conference, the delegation also arranged separate meetings with important leaders and international solution experts for in-depth exchange on digital transformation experiences. They included:

- (i) buildingSMART international chapter Chairman Ian Howell, CEO Clive Billiald and Marketing Director Aidan Mercer;
- (ii) buildingSMART Regulatory Domain group;
- (iii) Viking Museum contractor Statsbygg; and
- (iv) Catenda CDE solution.

#### (b) <u>Takeaways</u>

There are many potential developments and key lessons for Hong Kong from the events as follows:

- (i) Potential to have Hong Kong participants in the new Water Domain;
- (ii) Advancement of Digital Product Passports to exploit the power of openBIM across the asset lifecycle;
- (iii) Advancement of Digital Twin and Common Data Environment application in Hong Kong; and
- (iv) Further promotion of future international openBIM Awards in Hong Kong as openBIM here has started to gain international recognition, with more and more projects have used openBIM. There are five out of 22 finalists (23%) in 2023 comparing to one out of 21 finalists (5%) in 2022.

#### Way Forward and For Information

5.1 The CIC will continue to sustain the connections built during the visit, and to identify appropriate pioneers and case studies for sharing with the local industry to encourage the adoption of innovative technologies.





### **Digital Product Passports**

According to buildingSmart, the new Digital Product Passport (DPP) is central to the new Ecodesign for Sustainable Products Regulation (ESPR) and will provide information about the environmental sustainability of every product. It is expected that this information will be easily accessible by scanning technology and should help both consumers and businesses to make better decisions when choosing, operating, maintaining and replacing products.

The development of the DPP is at an early stage with discussion and consultation ongoing around issues such as how to store this data – whether for example to use a database or a complex system – and how to best access the data in use. Machine readability and machine interpretability of that data will be the key to the success of the DPP.


