		Members confirmed the Progress Report of the 1st CITB meeting held on 13 January 2015.

		 Members noted the following highlighted issues: i) Outsourcing certification test on excavator operation - the management had contacted the organizations that were approved by Labour Department to provide certification test on excavator operation to discuss the feasible ways of narrowing the gap of the charged fees. Yet, it was unsuccessful. The management would continue to consider other measures to increase the number of cooperative training places for excavator operation; ii) Update of CICMF Model - the CIC Research Group was awaiting the Focus Group on Projected Construction Expenditure to provide the projected construction expenditure covering the situation where the allocation of funds to many infrastructure projects had been delayed. Meanwhile, the data of registered workers as of end 2014 and the latest data of internal training at CIC were collected to update the part of supply in the model.

		Members noted the professional development and progression pathways for construction practitioners who started their career after leaving Secondary 3 or as semi-skilled workers as well as the route for those who started their career after leaving Secondary 6. Members then gave some comments on the matter.
2.4	CIC/CTB/P/010/15	Membership list for course advisory panels 2015/2016 and proposed list of substitute organizations
	(for discussion)	Members noted the list of 160 members and the proposed list for 21 unfilled places for course advisory panels (CAPs) in 2015/2016. A Member commented on the criteria in deciding the number of representatives from labour unions. The management would amend the proposal on the paper to reasonably address the issue of composition of CAPs.
2.5	CIC/CTB/P/011/15 (for discussion)	Re-allocating the remaining training places and budget of "Diploma in Vocational Education (DVE) Programme – Craftsman" to subsidize trainees of other related programmes of VTC
		Members approved using the remaining 79 subsidized places under DVE Programme – Craftsman and the related budget to subsidize the Telecommunications and Surveillance Technology stream under DVE (Digital Electronics Technology) Programme. The total number of training places and the total estimated expenditure would however remain unchanged, i.e. respectively 684 places and \$21 million plus.

		Members noted the progress of the above project and approved that subsidy to course fees for Senior Construction Workers Trade Management Course, Specified Training Course and Skills Enhancement Course that commenced on or after 1 February 2015 would be provided by CIC. The subsidy to trade test fees would also be ceased from 1 April 2015 while the remaining amount of the Government's funds would be used to subsidize the ECMTS courses. All these measures would additionally train around 1,640 graduates. When the funding for ECMTS used up, CIC would cease to use the name. Training places would continue to be provided through CIC full-time short courses and various cooperative training schemes. For trainees taking full-time short courses on trades classified as having manpower shortage, their trainee allowance would remain as \$320 per day in 2015 and would be reviewed in early 2016.

		Members noted the above and the incentive schemes to encourage workers to apply early for trade tests

In addition, Members agreed to the recruitment of manpower in stages and related financial estimates according to the lower limit (59,000 man-time) and the upper limit (77,000 man-time) as estimated for the testing capacity in 2015 and 2016.
