3.4	CIC/CTB/P/056/13 (for discussion)	Proposal for Contractor Cooperative Training Scheme (CCTS) – E&M trade (Fire Service Electrical Fitter) and (Fire Service Mechanical Fitter) The Committee approved the above contractor cooperative training scheme and its subsidy assessment mechanism, training contents and 55 training places.

		The Committee approved the proposed revisions to the course content of "Sub-contractor (marble worker) Cooperative Training Scheme" and accepted the related subsidy assessment mechanism and estimates.
3.8	CIC/CTB/P/065/13 (for discussion)	Proposed revisions to test papers of E&M trade test – Refrigeration /Air-conditioning /Ventilation Mechanic (Air System, Thermal System, Water System, Unitary System and Electrical Control) (Trade Test and Intermediate Trade Test)
		The Committee agreed to (i) lengthen the testing time by half an hour to 3.5 hours for Air System trade test; and (ii) revise the second question on installing cold water pump pipes and fittings in Water System trade test and require candidates to conduct electric welding procedures on spot according to the actual conditions. For the revisions to Air System intermediate trade test, the follow-up actions would be subject to the discussion in the meeting of the Working Group.

		The Committee accepted the proposed revisions to test papers of Electrical Wireman and Control Panel Assembler (Trade Test and Intermediate Trade Test).
3.10	CIC/CTB/P/067/13 (for discussion)	Proposed estimates for "Enhanced Construction Supervisor Training Scheme" The Committee considered that the fees of outsourcing the theory classes of Certificate in Civil Engineering Supervision (ZCV) and Certificate in Building

		Services Supervision (ZBS) and the trade training of ZBS were on the high side. It was proposed to conduct these courses by CIC itself with details to be submitted for the consideration of the Committee.
3.11	CIC/CTB/P/068/13 (for discussion)	Revalidation Training Course for Operators of Compactor The Committee agreed to offer the above revalidation course for in-service operators to renew their licenses. The course would last for one day including theory revision and 30-minute written test after class. Each participant would be charged \$210 and there would be 20 people per class.
3.12	CIC/CTB/P/069/13 (for discussion)	Proposal for establishing four different intermediate trade testing workshops at Lai Sun, Tong Fuk, Tai Lam Correctional Institutions The Committee agreed to the setting up of intermediate trade testing workshops at the above three correctional institutions and allowed these three correctional institutions to apply on behalf of their inmates for taking the intermediate trade tests and CIC designated invigilators to go to these institutions to conduct the tests.
3.13	CIC/CTB/P/070/13 (for discussion)	Definition of 9 categories of site supervision personnel The Committee noted the generic definition of site supervision personnel and its nine categories of job grades as well as the acceptance of the related research report last year. However, the report did not further study the definition of individual categories of job grades, and thus, the consultant concerned was invited to define the 9 job grades by categories as the basis for forecasting manpower of the site supervision personnel manpower forecasting model. In addition, the definition of categories of site

		supervision personnel was limited to supervision personnel working on construction sites and could only be used as reference for the manpower forecasting. The research consultant was reminded that the research should use job descriptions, rather than just job titles, for analysis.
3.14	CIC/CTB/P/071/13 (for discussion)	Full-time course graduates referral scheme It was approved to launch the captioned scheme first and a review would be conducted later subject to the feedback received. The Scheme would only be applicable to the 17 short courses/courses under Enhanced Construction Manpower Training Scheme (ECMTS) in need of enhanced recruitment efforts. The quota of the Scheme would be 2,000 trainees, of which 1,000 were expected to complete the course with the amount of reward capped at one million dollars.

		The prerequisite for cooperative training scheme was "employment first, training afterwards". However, the above papers could not show the employer-employee relationship between the employed trainees and the corresponding sub-contractors and there was no mention of the participating sub-contractors, sites, instructors and trainees. Therefore, the Committee would not assess the subsidy applications of these six cooperative training schemes at the moment.
