6th Progress Report of Committee on Subcontracting

Purpose

This paper outlines the main points discussed at the 6th meeting of the Committee on Subcontracting held on 17 September 2008. The record of attendance is at Annex A.

Items Discussed

- 2. Members discussed the following items
 - the proposal for taking over the operations of the Voluntary Subcontractor Registration Scheme (VSRS) from Hong Kong Construction Association and phasing out PCICB Registration Limited;
 - security of payment assessing the nature and extent of the problem;
 - findings of the survey on the register of subcontractors (Stage 2 of the VSRS);
 - update on the work plan; and
 - Enhanced Ethical Status for subcontractors registered on the VSRS.

Progress on Matters Arising from the 5th Meeting on 14 July 2008

- 3. Members noted the following
 - (a) paragraphs 24(a) to (f) the matters would be discussed in latter parts of the meeting; and
 - (b) paragraph 24(g) the Guidelines on Administration Charges for Reporting of Site Accident was endorsed by CIC for promulgation at the 11th meeting held on 28 August 2008. The CIC Secretariat would organise promulgation accordingly. The usage of the Guidelines would be reviewed in the first quarter of 2009.

Proposal for Taking Over the Operations of VSRS from Hong Kong Construction Association (HKCA) and Phasing Out PCICB Registration Limited (PRL)

4. Members noted that the CIC Secretariat had an initial proposal on taking over the operations of the VSRS as follows:

- (a) Initial phase
 - HKCA to remain as the Scheme Operator for another 6 months
 - The CIC Secretariat to take over from the Development Bureau the secretarial services for the Management Committee of the VSRS
 - CIC to be the Scheme Owner by 1 January 2009 and PRL to be closed accordingly
- (b) Final phase
 - The CIC Secretariat to perform the role of Scheme Operator
 - Additional staff to be in place to administer the VSRS
 - A new computer system to be developed to improve operational efficiency and to cater for Stage 2 of the VSRS
 - A suitable location to be identified for accommodating the VSRS office
 - The operational process to be reviewed with a view to streamlining relevant procedures

5. Members also noted that HKCA had proposed not to renew the current service agreement after 25 November 2008 considering its constraints on internal resources. However, the Chairman cautioned that there would be insufficient time for the CIC Secretariat to familiar with the operations by 25 November 2008. To minimize operational risks, HKCA was advised to consider continuing its obligation to ensure the smooth running of the VSRS.

6. A Member advised the CIC Secretariat to explore whether the existence of PRL would be helpful to screen off unnecessary liability before proceeding to wind up PRL.

7. The Committee agreed to adopt the proposal on taking over the operations of the VSRS as described in paragraph 4 subject to –

(a) further discussion with HKCA on the renewal of the current service agreement; and

(b) endorsement on resources deployment by the Committee on Administration and Finance.

[Post-meeting note: HKCA has agreed to renew the current service agreement for another six months until 25 May 2009. The Committee on Finance and Administration has approved the recruitment of a manager and three clerical staff for the operations of the VSRS.]

Security of Payment – Assessing the Nature and Extent of the Problem

Survey Findings on General Building Contractors' and Specialist Contractors' Status on Cash Flow and Other Related Issues (Survey on Contractors) by Hong Kong Construction Association (HKCA)

[Mr Thomas Tse of HKCA together with Dr Robert Chung, Ms Karie Pang and Ms Winnie Lee of HKU joined the meeting at this juncture.]

8. HKCA commissioned the Public Opinion Programme at the University of Hong Kong (HKU) to conduct the Survey on Contractors to reveal cash flow problems faced by contractors. Target respondents included members of HKCA and The Hong Kong Federation of Electrical and Mechanical Contractors Limited. Members received a presentation from Dr Robert Chung and major findings were summarized as below –

- (a) Inflation and high cost of materials was a major problem facing contractors. Another critical problem was outstanding payments from the other contracting parties.
- (b) "Variations under assessment" was the main reason for payment in disagreement with the other contracting parties.
- (c) The mean percentage of overall payment withheld due to disagreement/dispute with employers or other contract parties over the past 12 months was 10% of the original contract sum.
- (d) "Insufficiency of cash flow" was not considered as a serious problem by contractors while the severity of "Outstanding payment to subcontractors" was even lower.

[Mr K H Tao left the meeting at 4:00 pm.]

9. Dr Chung added that the survey results were worked out from the number of respondents only without taking account of the respective market shares.

[Mr Thomas Tse, Dr Robert Chung, Ms Karie Pang and Ms Winnie Lee left the meeting after the presentation.]

10. Members acknowledged that the problems of outstanding payment from the other contracting parties and payments withheld due to disputes would deserve further study.

Survey on Cash Flow Problems in the Construction Supply Chain

11. The Survey on Contractors reflected that the main contractors suffered from outstanding payments. Members wondered why the situation neither transmitted into cash flow problems nor impacted on downstream subcontractors. However, the Survey on Contractors did not probe into the issues due to limited resources allocated by HKCA.

12. Members considered obtaining a complete picture of the problems encountered by other parts of the supply chain through a comprehensive survey was necessary. As for the survey methodology, it should be based on the questionnaires for the HKCA survey with modifications to address the different positions of developers, consultants, subcontractors and suppliers. The findings of the proposed survey should be analyzed jointly with the findings of Survey on Contractors to come up with an overall picture relating to cash flow and outstanding payment issues in the industry. As such, Members agreed to commission a comprehensive survey with a view to analyzing the problem of security of payment in the industry and considering the necessity and appropriateness of resolving the problem through legislation

13. To obtain funding for the proposed survey, the CIC Secretariat would make a submission to the Committee on Administration and Finance for consideration.

[Post-meeting note: The Committee on Administration and Finance at its meeting of 26 September 2008 agreed that the funding request be considered directly by CIC.]

Escrow Accounts for Retention Money

14. Members noted the discussion at the CIC meeting held on 28 August 2008 regarding the legal viability for CIC to manage escrow accounts and agreed the CIC Secretariat to seek legal advice on the issue and report the result to the Committee at the next meeting.

Findings of Survey on the Register of Subcontractors (Stage 2 of the VSRS)

15. The proposed structure and key parameters for the Register of Subcontractors were found to be affirmative according to the survey findings. An overwhelming majority of the respondents indicated their support for the 3-grade register and the adoption of the existing trade classification for the proposed register. As for setting financial limits on the value of individual subcontracts undertaken by subcontractors of the entry grade and the intermediate grade, majority of the respondents supported the proposal.

16. Members agreed that proper consultation with subcontractors would be necessary as to setting the entry requirements and the financial limits for each grade. With Mr TSE Chun-yuen as the leader and the assistance of Mr Lawrence NG, the CIC Secretariat would work with Mr TSE and Mr NG to form a working group to recommend a suitable structure. A Member suggested the working group to consider setting compliance with safety standards as one of the entry requirements and formulating a re-grading mechanism within the register.

Update on Work Plan

17. Members noted the updated work plan. The CIC Secretariat was asked to separate "Guidelines on Measures for Protection of Workers' Entitlement to Wage Payment" as an individual item while other possible solutions to address the problem of security of payment could be further investigated in the discussion of "Security of Payment". It was envisaged that the latter would take longer time.

[Post-meeting note: A revised work plan is at Annex B.]

Enhanced Ethical Status (EES) for Subcontractors Registered on the VSRS

18. It was reported that an informal meeting was held on 4 August 2008 to discuss the revised Rules and Procedures of the Primary Register for the purpose of introducing EES in the VSRS. They had also touched on the feasibility of making use of an independent list instead of the VSRS because ICAC only aimed to assist Owners' Corporations in identify ethical contractors for building maintenance works but not all subcontractors.

19. In response to Members' request for clarifying whether the Committee had confirmed to support using the VSRS as a platform for introducing the EES, the CIC Secretariat was requested to circulate to Members the relevant meeting record for further perusal.

[Post-meeting note: Extracts from the meeting records of the following meetings (Annex C) were circulated to Members by an email on 25 September 2008:

- the 4th Progress Report and the 5th Progress Report of the Committee
- the 9th Meeting of Construction Industry Council
- the informal meeting held on 4 Aug 2008]

20. As to the definition of "collusion", Members agreed to adopt the definition stipulated in the tender documents of the Housing Department.

21. ICAC confirmed that they would not insist on including the requirement to revoke the registration status of a subcontractor involved in misconduct before conviction.

22. In view of the ICAC's latest position and the consensus on the definition of "collusion", the CIC Secretariat was directed to further study the introduction of the EES in the VSRS to facilitate Members' discussion at the next meeting.

Further Actions

- 23. The following further actions were agreed
 - (a) the CIC Secretariat would further discuss with HKCA on the renewal of service agreement regarding the operations of the VSRS;
 - (b) the CIC Secretariat would seek endorsement from the Committee on Administration and Finance on resources deployment for taking over the operations of the VSRS;
 - (c) the CIC Secretariat would seek legal advice on whether the existence of PRL would be helpful to screen off unnecessary liability;
 - (d) the CIC Secretariat would solicit funding support from CIC to commission the comprehensive survey on problems of cash flow and outstanding payments in the construction supply chain;
 - (e) the CIC Secretariat would seek legal advice on the legality of managing escrow accounts for retention money by CIC;

- (f) a working group would be formed to advise on entry requirements and financial limits to be applied on each grade of the Register of Subcontractors under Stage 2 of the VSRS; and
- (g) the Secretariat would circulate again the relevant minutes and progress reports on the discussion of introducing EES for subcontractors registered on the VSRS and would prepare a paper to facilitate Members' discussion at the next meeting.
