	(for discussion)	Item 2.2 – Regarding the 12 previously funded research projects related to environment and sustainability, CIC Secretariat updated the status which all research projects are completed, except the "Thermoelectric Cooling for the Construction of Solid-state Air Conditioner in the Lift". CIC Secretariat will review the key findings of this project with an anticipated final report completion by May 2019.
		Item 2.2 – Regarding the update of the McKinsey Interim Report follow up, members took note of the following updates:
		CIC Secretariat reported that the feasibility report for "Potential Utilisation of Prefabrication Yards and Prefabrication Components in Hong Kong" has been published on the website and the key findings have been disseminated to Development Bureau and Hong Kong Construction Association for further consideration.

		CIC will invite consultants for the "Preparation of a Guidebook on Sustainable Construction and Development of a Sustainable Construction Assessment Scheme" through open tendering process and the project is targeted to commence in the first quarter of 2019.
		The CIC Sustainable Construction Award Conference and Presentation Ceremony was held on 26 October 2018 with over 280 participants. CIC Secretariat will organise the post event activities in the first quarter of 2019 and promote the best practises into a Guidebook on Sustainable Construction.
		PricewaterhouseCoopers (PwC) has submitted the Phase I Completion Report for the consultancy services on "Improving the Environmental Performance of the Hong Kong Construction Industry" in June 2018. For Phase II, PwC is preparing several interventions and action plan for adoption of low carbon construction with a target completion by April 2019.
		Item 2.4 – Regarding the Com-ENV 3-Year Achievement Statement, Members were briefed about the revised timeline of the key deliverables. Members endorsed the Chinese version of the 3-year Achievement Statement.
		Item 2.6 – Regarding the proposed study under the Pneumoconiosis Compensation Fund (PCF), CIC Secretariat will meet up with PCF Board to explore further opportunity for potential collaboration.
