Approximately 100 persons from stakeholder organisation attended the forum and some had expressed their views. The chairperson advised that he would provide comments to LD on behalf of Com-CSY. The CIC Secretariat was consolidating all the comments from stakeholders for submission to LD.

	(for information)	Members took note on the work progress on the Centre for Construction Safety:
		 The design consultant reported the progress and proposed two designs for consideration. Committee Members expressed that the design should avoid any modification to the original building structure as far as possible. Committee Members discussed the designs of the safety exhibition area and suggested to use "Past", "Present" and "Future" as the theme of different zones. The Chairperson advised that he and the three Subcommittee Chairpersons will hold regular meetings with the Hong Kong Institute of Construction and the design consultant to discuss the development and the holding content of the Centre for Construction Safety. The design consultant will consolidate all comments and revise the design for discussion at the next meeting.

		 and the importance that everyone should reject to work under unsafe condition would be emphasised. The entry qualification requirement for the "Construction Safety Supervisor Course" and the "Basic Site Safety Supervising Technique Course" would be maintained as "3 years' relevant working experience". It was considered that only trained persons with relevant experience and tested for competence shall be endorsed to carry out supervision work. To tackle the shortage of supervisor with lifting operation and management experience, it was suggested to develop a lifting supervisor training course. A Member suggested to lower the minimum admission requirement of "3 years' relevant working"
		experience" in the Lifting Safety Supervisor course. The Chairperson suggested that priority shall be given to those with 3 years' relevant working experience. The Subcommittee will discuss the matter in the next meeting.

		• In view of the fatal accidents related to truss out scaffolding works in recent years, it was suggested to setup a Truss Out Scaffold Working Group to review the existing legislation, code of practice and regulatory practice of truss out scaffolding works to enhance the understanding the safety management of such works and the responsibilities of relevant stakeholders. The proposal to set up the Working Group had been approved by Members of the Committee on Construction Safety via e-mail circulation by the CIC Secretariat.

		Review of the safety responsibilities and roles of developers had been completed with the following suggestion:
		 Design Safety Classify public works by departments and consider to prepare detailed design for safety guideline. Make use of the guideline of Housing Authority as a model to prepare a Design for Safety guideline for the private sector. Based on the different types of project to produce relevant design for safety guidelines. Study the development process of Design for Safety in Singapore and the UK, and prepare roadmap for Hong Kong. Pay for Safety Existing "Pay for Safety Scheme" items have become industry basic requirements. It is suggested DEVB carried out a review of the current "Pay for Safety Scheme". Reasonable Contract Period Develop a Reasonable Contract Period Guideline with developers and other relevant stakeholders. Document developer's roles and responsibilities in the Guideline on Safety Responsibilities and Roles of Key Stakeholders and introduce mechanism to handle timely granting of extension of time in contracts.

		• Activities would include safety symposium, site visit, "Safety Gathering", "Considerate Contractors Site Award Scheme", safety video competition, BIM Talk x Safety seminar, etc.
		• Develop Virtual Reality (VR) training kits and purchase VR training googles and distribute them through "Safety Gathering" to project sites for training (on safe working at height) purpose.
