As of the end of May 2019, there were 1,639 Registered Specialist Trade Contractors (RSTCs) and 4,489 Registered Subcontractors (RSs); (b) The Development Bureau, Housing Department, Housing Society and Urban Renewal Authority already mandated the employment of RSTCs in their projects while MTR Corporation and Airport Authority were revising their relevant contract clauses accordingly; (c) The Secretariat would strengthen collaborations with other departments on promotion of the Scheme via a series of events below: (i) 19 July 2019: Innovation in Practice Forum (ii) 21 and 27 August 2018: BIM Experience Workshops (Civil and Building Trades) for RSTCs and RSs (iii) 26 September 2019: Wealth Management Talk cum Guided Tour to Construction Innovation and Technology Application Centre (iv) October or November 2019: Construction Innovation and Technology Fund Forum (v) 20 November 2019: Guided Tour to Hong Kong Construction Industry Trade Testing Centre cum Introduction of the CIC Apprenticeship Scheme
