		In light of the close linkage between the work of Task Group 2 (Standard Special Conditions of Contract for BIM) and Task Group 3 (Standard BIM Service Agreement), the two Task Groups had been merged into one. The contract for the consultancy of standard BIM contract documents drafting would be awarded in early August 2020.
		Members took note of the progress of the Task Force.
2.11		Task Force on Reasonable Construction Period
		A number of stakeholder engagement sessions would been conducted on the initial findings of the study on Reasonable Construction Time Index in July 2020.
		The COVID-19 situation has caused a slight delay to the interview and stakeholder engagement phase of the study. Accordingly, Members agreed to extend the term of the Task Force by a year until March 2021.

		(a) The release of the Report on Site Supervision Practice would be withheld until the legal proceedings on related incidents are settled.
		(b) The Secretariat would draft a letter to Development Bureau enquiring the details and progress of the enactment of the Security of Payment Legislation.

		(c) CBD would support the implementation of monthly wage employment of workers by developing sample templates of contract clauses and employment contracts.
		(d) CBD has conducted a number of webinars on related topics. More is planned until the end of the year.
		(e) Members were briefed on a number of visits and conferences in the Greater Bay Area but attendance would be subjected to any travel restriction under COVID-19.
		(f) To raise efficiency, Members approved to delegate the Task Forces with the authority to approve interim deliverables of projects under their purview.
