Candidate who fails the practical test far below the passing requirement for the Intermediate Trade Test (or Trade Test) and applies for a re-sit within 6 months (or 1 year) have to pay a surcharge*.
Pass	(<mark>Ž</mark>) Fail	 The re-sit application fee for the practical test is same as a full test application fee. The written test result is valid for 3 years. Candidate who fails the practical test far below the passing requirement for the Intermediate Trade Test (or Trade Test) and applies for a re-sit with in 6 months (or 1 year) have to pay a surcharge*.
(<mark>X</mark>) Fail	⊘ Pass	 The re-sit application fee for written test is HK\$100. The practical test result is valid for 3 years.

Surcharge for Working Visa Holders

Working Visa Holders

The application fee for Working visa holders is 3 times of the basic testing fee. Please inform CIC team when submitting applications for our necessary arrangement.



Intermediate Trade Test



Absentee applying for a re-sit within **6 months** have to pay a surcharge of HK\$500 per trade.

Absentee applying for a re-sit within 1 year have to pay a surcharge of **HK\$1,000** per trade.

Note 1: Candidates who contravene any of the regulations listed in the « Disciplinary Regulations for Candidates In Trade Test $\$ could be disqualified for the relevant trade test. Disqualification resulted from all kinds of contravention would be generally regarded as 'absent'.

Note 2: All application fees are non-refundable for absentees. Absentees are required to re-submit new trade test submission.

Note 3: The surcharge for absentees are non-refundable.
