In view of this, the Task Force on Site Safety Incidents under Committee on Construction Safety of the CIC has issued a *Safety Alert No. 001/18 Lifting Operation Safety* to enhance safety awareness on lifting operation in construction industry.

On top of this, the CIC organises CIC Seminar with speakers from Hong Kong Institute of Construction of CIC, Housing Department, Occupational Safety and Health Council, Hong Kong Federation of Occupational Safety and Health Associations, Hong Kong Professional Hoisting Engineering Association and Main Contractor to share their experience on lifting operation safety on 12 March 2018.
