

**Construction Industry Council**  
**1<sup>st</sup> Progress Report of Committee on Subcontracting**

**Purpose**

This paper outlines main points discussed at the 1<sup>st</sup> meeting of the Committee on Subcontracting held on 17 May 2007. The record of attendance is at Annex A.

**Issues Discussed**

*(A) Terms of reference and Membership*

2. Members discussed and endorsed the membership and terms of reference for the Committee at Annex B. They noted that the third item of the terms of reference on improving the management of subcontractors would cover security of payment for the whole construction supply chain. Members agreed that co-opted members would serve as advisers to the Committee and be invited to attend Committee meetings on need basis to contribute on matters relevant to their interest and expertise. Subject to the availability of suitable candidates, the Committee would consider co-opting additional members with subcontracting background so as to strengthen the contribution of subcontractors.

*(B) Priority Tasks*

3. Members agreed to pursue the priority tasks at Annex C and expressed preliminary views on the way forward.

4. On the Voluntary Subcontractor Registration Scheme (VSRS), the Hong Kong Construction Sub-contractors Association would advise on the trades that should be added to the Primary Register to accommodate subcontractors who could not be fitted into the current trade classification. On the operation of the VSRS, subject to endorsement by CIC, Mr S S Lee would take over the chairmanship of the Management Committee of VSRS and Mr TSE Chun-yuen would replace Mr Peter Ayres as one of the members of the Management Committee. With the task of establishing a register of firms engaged in subcontracting business substantially accomplished, efforts should be made to pursue the next stage involving a Premier Register with more stringent entry requirements.

5. On training and raising the standard of subcontractors, Members considered that it would be crucial for CIC to render tangible support to registered subcontractors in improving their performance. Efforts should also be made to raise subcontractors' awareness of the importance of effective management of their business operations, contractual relationship with main contractors and finance, in particular in relation to the timely application of payment for completed works and assessment of variations. In this regard, the former PCICB had organized training courses on construction-related matters such as construction site safety legislation and waste management measures. Consideration should therefore be given to introducing management-related courses such as standard forms of subcontracts and dispute resolution.

6. The discussion on security of payment would encompass the whole construction supply chain including main contracts, various types of subcontracts and sub-subcontracts and wage payment for workers. Priority should be accorded to this subject with a view to arriving at a consensus on the need for security of payment legislation.

7. On standard form of subcontracts, HKCA would publish the revised Standard Form of Domestic Sub-contract (the "Blue Form") incorporating the revisions agreed between HKCA and HKFEMC in 2006. The two associations would continue to pursue further improvements to the Blue Form including those requiring corresponding changes to the main contracts between main contractors and Government and would refer relevant issues to the Committee for advice and guidance.

8. PCICB issued the Guidelines of Standard Form of Domestic Subcontracts for Basic Trades in May 2005 to promote the use of written subcontracts incorporating equitable terms. The Committee would review the adoption of the Guidelines at an appropriate juncture and continue to promote the use of written subcontracts.

9. Members also reviewed CIC's role on standard forms of subcontracts and concluded that instead of undertaking the development and improvement of standard forms directly, CIC should concentrate on assisting concerned parties to do so and providing advice and guidance when necessary.

## **Any Other Business**

10. The Secretariat would compile a summary of the discussions of the PCICB Working Group on Management of Subcontracting to serve as background information in pursuing the priority tasks of the Committee.

## **Further Actions**

11. The following further actions were agreed –
- (a) Upon endorsement of the membership of the Committee by CIC, the Secretariat would issue letters inviting co-opted members and Government's representatives to join the Committee and attend future meetings;
  - (b) Subject to endorsement of CIC, Mr S S Lee would take over the chairmanship of the Management Committee and Mr Tse Chun-yuen would replace Mr Peter Ayres as member of the Management Committee;
  - (c) Hong Kong Construction Sub-contractors Association would advise on the trades to be added to the Primary Register to accommodate subcontractors who could not fit into the current trade classification; and
  - (d) The Secretariat would compile a summary of the discussions of the PCICB Working Group on Management of Subcontracting for Members' reference.

1. To operate and develop the Voluntary Subcontractor Registration Scheme (VSRS).
2. To raise the professional standard of subcontractors through providing training courses and other value-added services under the VSRS and coordinating the training organized by other organizations.
3. To examine current arrangements for selection and management of subcontractors and recommend improvements.
4. To promote use of written subcontracts.

Given PCICB's lack of staff resources, the Hong Kong Construction Association (HKCA) provides administrative support for the scheme as Scheme Operator under a service agreement.</li> <li>• The Management Committee had been established under PCICB to oversee the operation of the Primary Register and to make decisions on applications on registration.</li> <li>• A questionnaire survey was conducted in mid-2006 to obtain the feedback of registered subcontractors on the Primary Register. The improvements at Annex C were recommended by the PCICB Working Group on Management of Subcontracting on the basis of the results of the survey.</li> </ul>	<ul style="list-style-type: none"> <li>• To consider the changes to be made to the Primary Registration to suit the migration from PCICB to CIC including changing the membership of the Management Committee and transferring the ownership of PCICB Registration Limited to CIC.</li> <li>• To take forward recommended improvements at Annex D.</li> </ul>

- Co-ordinate provision of training to subcontractors by various training institutions
- Secure discounts for Registered Subcontractors in attending training courses
- Organize part of the training courses outside office hours

**New Value-Added Services**

- Issue regular newsletters to Registered Subcontractors to update on recent developments affecting them
- Establish resources centre to provide reference information

**Other Improvements**

- Discuss with Registered Subcontractors on the establishment of subcontractors associations
