		<p>Carnival was supported by 15 supporting organizations and 125 participating organizations.</p> <p>(c) The CIC awarded the “Outstanding Pioneer Appreciation” to 374 workers and the “Caring Company Appreciation” to 34 companies. Moreover, 502 awards were given under the Construction Industry Workers Professional Development Scheme, and 39 scholarships were awarded to the families of registered construction workers.</p>
4.4	CIC/CRB/P/021/24 (for information)	<p>Proposal for the 2025 Construction Workers Festival – Outstanding Craft Master Award</p> <p>(a) In line with the CIC to designate 2025 as the Year of Professionalism, the CIC will organise the Outstanding Craft Master Award Ceremony on 2 November 2025 to signify the professional skills and contributions of frontline workers.</p> <p>(b) Members supported the Outstanding Craft Master Award to honour professional craftsmen with outstanding performance. They suggested incorporating Chinese tradition and culture and the professional image of Master Lu Ban into the event to promote the spirit of craftsmanship and to further promote the construction industry to society. The CWRB will establish an Organizing Committee to plan the Outstanding Craft Master Award and other activities for the Construction Workers Festival.</p>

4.6	CIC/CRB/P/023/24 (for information)	<p>Report of Sub-committee on Data Analysis Meeting No. 003/24</p> <p>(a) As of September 2024, according to data expansion analysis, there were a total of 410,624 registered workers engaged in the construction industry.</p> <p>(b) The statistics from the Census and Statistics Department indicate that the unemployment rate in the construction industry slightly increased to 4.4% in the period from July to September 2024. Within this period, the unemployment rate for foundation and building works stood at 4%, while for decoration, repair, and maintenance for buildings sector, it was 5.8%.</p> <p>(c) The Sub-committee on Data Analysis analysed the attendance hours of workers of core trades. The attendance data showed that the average daily attendance hours of workers of core trades ranged from 7.2 to 8.9 hours, which was consistent with the working hour requirements of the relevant trades.</p>
4.7	CIC/CRB/P/024/24 (for information)	<p>Report on Inspection and Enforcement</p> <p>(a) From January to November 2024, a total of 1,572 construction site inspections and a total of 1,911 workers' daily attendance records (DAR) were checked.</p> <p>(b) From January to November 2024, a total of 132 summonses were issued. 137 summonses resulted in convictions in court (including those summonses issued in 2023).</p> <p>(c) From January to November 2024, 19 seminars on "Designated Workers for Designated Skills" and "Construction Workers Registration System (CWRS)" were held to explain the</p>
