		Project completed. Final payment will be arranged upon receiving the invoice.
1.3	CIC/ENV/P/001/22 (for approval)	Progress Update on CIC Sustainable Finance Certification Scheme
		Members were briefed on the progress of the phase 2 implementation plan including the stakeholder engagement, assessor training and third-party verification.
		Member agreed to relax the criteria for the early bird package such that each company could enjoy early bird package once for each financial product. Members suggested Cundall to review the operator fee for the second and subsequent post-lending applications, providing breakdown of manpower, workload and financial implications.
		Accreditation service for sustainable finance schemes is not available in Hong Kong and some other Asian and European countries. Cundall would further explore accreditation service in the United States. CIC would follow up to ensure the measures on assessor integrity and cyber security are sufficient.
		Members approved the assessor training programme proposal and training materials, the phase 2 SFCS E-platform, the proposed enhancement of Early-bird Package and the release of stage payment.
