 Pass	 Fail	<ul style="list-style-type: none"> <li>▶ The re-sit application fee for the practical test is same as a full test application fee.</li> <li>▶ The written test result is valid for 3 years.</li> <li>▶ Candidate who fails the practical test far below the passing requirement for the <b>Intermediate Trade Test</b> (or <b>Trade Test</b>) and applies for a re-sit with in <b>6 months</b> (or <b>1 year</b>) have to pay a surcharge*.</li> </ul>

Surcharge

## Surcharge for Working Visa Holders

### Working Visa Holders

The application fee for **working visa** holders is **3 times of the basic testing fee**. Please inform CIC team when submitting applications for our necessary arrangement.

## Surcharge for Absentees

### Intermediate Trade Test

Absentee applying for a re-sit within **6 months** have to pay a surcharge of **HK\$400** per trade.

Note 1: Candidates who contravene any of the regulations listed in the 《Disciplinary Regulations for Candidates In Trade Test》 could be disqualified for the relevant trade test. Disqualification resulted from all kinds of contravention would be generally regarded as 'absent'.

Note 2: All application fees are non-refundable for absentees. Absentees are required to re-submit new trade test submission.

Note 3: The surcharge for absentees are non-refundable.

### Trade Test

Absentee applying for a re-sit within **1 year** have to pay a surcharge of **HK\$800** per trade.

### Intermediate Trade Test

Candidate who fails the practical test and the test result is far below the passing requirement, applies for a re-sit with **6 months** have to pay a surcharge of **HK\$400** per trade.

Note: Surcharge incurred in the re-submission is refundable upon achievement of an overall pass result in the related trade test.

### Trade Test

Candidate who fails the practical test and the test result is far below the passing requirement, applies for a re-sit with **1 year** have to pay a surcharge of **HK\$800** per trade.

## Discount Offers for Trade Tests

The following discount offers are only applicable to **Trade Test application**. Applicants can choose one of the following offers:

### 50% Off for the Holder of Intermediate Trade Test qualification\* Condition

Holder of the corresponding Intermediate Trade Test Certificate  
Note: Not applicable to Construction-related Electrical and Mechanical Trade Tests

#### Fee Calculation

Trade Test basic fee **x50%**

### 20% Off for the Holder of any Trade Test qualification\* Condition

Holder of any Trade Test Certificate

#### Fee Calculation

Trade Test basic fee **x80%**

\* Intermediate Trade Test and Trade Test qualifications refer to an Intermediate Trade Test or a Trade Test Certificate issued by the Construction Industry Council.
