## Points to Note:

- 1. If you furnish any false information or make any false statement, your request for appeal may be rejected and you may be liable to prosecution.
- 2. This "Notice of Appeal" should be submitted to the Construction Industry Council within 2 weeks after the Registrar has notified you in writing of the decision made under Section 51(7)(b) of the Construction Workers Registration Ordinance.
- **3.** The prescribed fee payable in respect of a "Notice of Appeal" is HK\$30. Payment can be made by cash (in case that the "Notice of Appeal" is submitted in person) or by crossed cheque payable to the "Construction Industry Council". All fees paid are not refundable, regardless of whether the appeal is successful, unsuccessful or withdrawn.
- **4.** The duly completed "Notice of Appeal" and the prescribed fee should be submitted in person or by post to the Construction Industry Council at 38/F, COS Centre, 56 Tsun Yip Street, Kwun Tong, Kowloon.
- 5. In case that the space provided in the "Notice of Appeal" is insufficient, please write on separate sheet(s), attach all the sheets to the Notice and specify therein.
