Renaming of Committees and Updated Terms of Reference

To better reflect the nature of work under the purview of the committees under the CIC, the revised names and terms of reference of the committees are approved.

Furthermore, the terms of reference of each standing committee has also been revised to incorporate elements of innovation, technology and research within the scope of the committees. The wordings have been amended, where appropriate, to achieve consistency across the committees. The updated terms of reference are as follows:

Committee on Construction Safety

- 1. To review and monitor safety performance of the construction industry.
- 2. To review and enhance the mechanism of safety management.
- 3. To encourage the adoption of new technology and innovative ideas in construction safety.
- 4. To conduct research on enhancing safety performance of the construction industry.
- 5. To identify and recommend measures for improving safety performance to CIC.
- 6. To promote the adoption of the improvement measures by the construction industry.
- 7. To nurture a safety culture for the construction industry.

Committee on Environment

- 1. To promote environmental protection and sustainable development in the construction industry.
- 2. To promote good practices in relation to sustainable construction.
- 3. To encourage the adoption of new technology and innovative ideas in environment protection.
- To conduct research on enhancing environmental protection and sustainable development in the construction industry.
- 5. To advise on the strategy for development of construction standards.



Committee on Construction Procurement

- To review current practices on procurement in relation to project planning, tendering, contract administration
 and site supervision and promote good practices to improve the quality and cost effectiveness in delivery of
 construction contracts.
- 2. To promote good practices relating to dispute resolution.
- 3. To encourage the adoption of new technology and innovative ideas in construction procurement.
- To conduct research and provide value-added services under the Subcontractor Registration Scheme (SRS) for the elevation and enhancement of subcontractors professional standards.
- 5. To operate and develop the SRS.
- To review current arrangements for selection and management of subcontractors and recommend improvements.
- 7. To promote the use of written subcontracts.

Committee on Productivity

- 1. To compile and update key performance indicators related to the construction industry.
- To review current productivity level in the construction industry by introducing measurable indicators for different work trades.
- 3. To encourage the adoption of new technology and innovative ideas to elevate construction productivity.
- 4. To conduct research on benchmarking or setting standards for the productivity of construction process.
- 5. To provide statistics in relation to construction productivity.
- To recommend strategies to the Council and Boards/Committees for enhancing the industry's productivity and competitiveness.
- To co-ordinate and promote construction research and development and facilitate for elevating construction productivity.

Enhancing Safety of Lorry-mounted Cranes

On 14 March 2016, members of the former Task Group on Safety of Lorry-mounted Cranes conducted a site visit to examine body builders of lorry-mounted cranes and test the pre-use checklist prepared for the industry. After refinements were completed, the checklist was published in the form of a *Safety Alert*.



Construction Safety Week 2016

With the huge success of the activities held during Construction Safety Week last year, the Development Bureau and the Construction Industry Council co-organised Construction Safety Week 2016 (25 – 27 May) with the aim of continuing to promote and reinforce the "Zero Accident" message to industry stakeholders. The main theme of Construction Safety Week 2016 was "Design for Safety" focusing on Temporary Works Design.

Construction Safety Week Conference

The Conference held at the Hong Kong Convention and Exhibition Centre on 25 May was the main feature event of Construction Safety Week 2016. The Conference offered a platform for industry practitioners, other stakeholders, and local and overseas speakers to share initiatives and experiences in construction safety. The target audience included management from relevant government departments, employers, consultants, contractors, subcontractors and frontline practitioners such as workers, safety officers and site supervisors. The Conference received an overwhelming response with nearly 600 attendees.

(1) Construction Industry Safety Award Presentation Ceremony cum Fun Day

The event was jointly organised by the Labour Department, the CIC and other key industry stakeholders. Ms. Sally LEUNG, Manager – Council Services, also represented CIC and received a souvenir for participating in the competition's field assessment.

Committee on Environment

Tour of New TVSC Prefabrication Facility

Members of the Committee on the Environment joined the opening ceremony and guided tour of the TVSC prefabrication facility in Tsing Yi on 30 March 2016. The tour introduced visitors to the operations of the yard as well as various supply lines for them to better understand the prefabrication process. The facility will provide prefabricated steel reinforcing bar products for public works. TVSC is a joint venture between VSC Steel Processing Limited and NatSteel of Singapore.





Research on River Sand Substitutes for Concrete Production and Cement Sand Mortar Production (Phase Two) Final Report

The CIC formally published the Research on River Sand Substitutes for Concrete Production and Cement Sand Mortar Production (Phase Two) Final Report on 24 March 2016. The report looks into the formulation of practical solutions for using river sand substitutes in Hong Kong as well as the development of relevant standards and specifications.

Trials will be conducted to verify practicability on actual sites and compare the results obtained from the laboratory before promotional work and broad adoption take place.





Research on River Sand Substitutes for Concrete Production and Cement Sand Mortar Production (Phase Two) Final Report

Consultant Appointed for the Survey on the Potential Utilisation of a Prefabrication Yard

Tender assessment for consultancy services for the Survey on the Potential Utilisation of a Prefabrication Yard in Hong Kong was conducted on 22 February 2016. Mercado Solution Associated Ltd (MSA) was awarded the role. MSA is studying the background information to prepare an inception report and a survey framework for further review.

Consultancy Services on the Strategy for Management and Reduction of Construction & Demolition (C&D) Waste

Tender assessment for consultancy services on the Strategy for Management and Reduction of Construction & Demolition (C&D) Waste in Hong Kong was conducted on 11 March 2016. PolyU Technology and Consultancy Co. Limited was awarded the role, and a kick-off meeting was held on 20 May 2016.



Committee on Construction Procurement

Technical Seminar on Competition Law for the Construction Industry

A technical seminar on the implications of the Hong Kong Competition Ordinance for the construction industry was held on 15 March 2016 to educate and promote compliance among industry stakeholders. The event was organised by the former Task Force on Competition Law established under the Committee on Construction Procurement and was well-received.

The technical seminar kicked off with a presentation by Ms. Jingjing ZHAO, Senior Manager (Legal) of the Competition Commission on compliance with the ordinance. Mr. James WILKINSON, Senior Associate of King and Wood Mallesons then gave an update on the landscape since the law came into full effect in mid-December 2015. Mr. Edmund WAN, Partner of King and Wood Mallesons, explained how to prepare for investigations by the authorities. The technical seminar concluded with a panel addressing questions from the audience.

The CIC will organise another seminar on the Competition Law in Cantonese in December 2016.

Reference Materials for Standard Form of Domestic Sub-contract Published

The Committee on Construction Procurement under the CIC has published Reference Materials for Standard Form of Domestic Sub-contract following industry consultation on the draft in 2014.

User-friendly and simple written contracts readily available for adoption by sub-contractors could minimise payment problems.

The following key principles were adopted to produce the reference materials:

- The standard forms contain fair, equitable and balanced terms for easy adoption in domestic sub-contracting instances between the main contractor and the first-tier sub-contractor, and between the sub-contractor and lower-tier sub-contractors.
- The standard forms take into account existing good practices in the industry and the principles set out in the Guidelines on Standard Forms of Domestic Sub-contracts for Basic Trade published by the then Provisional Construction Industry Co-ordination Board.
- The standard forms cover core provisions which would be common across different trades.

HKIE technical seminar on the "Carbon Footprint to Steel Reinforcing Materials in Hong Kong"

A seminar on the "Carbon Footprint to Steel Reinforcing Materials in Hong Kong" was held on 7 April 2016 by The Hong Kong Institution of Engineers. Dr. James WONG, Assistant Manager - Research and Development of the CIC, delivered a speech on the Carbon Labelling Scheme for Construction Products and guidelines for the quantification of product carbon footprints.

Industry practitioners - including consultants, contractor and developers - expressed interest in the carbon labelling scheme. The CIC will continue to work with various stakeholders to enhance the sustainable development of the construction industry.

Briefing for Site Investigation Contractors

The CIC and the Site Investigation Contractors Committee of the Hong Kong Contractors Association (HKCA) co-organised a briefing on 17 March 2016 to explain the requirements of "Designated Workers for Designated Skills" for contractors conducting ground investigation work and to ensure their workers have registered with the appropriate trade divisions. Forty representatives attended the briefing, which also saw a lively Q&A session.

Trial-run Inspections for "Designated Workers for Designated Skills"

To prepare for the "Designated Workers for Designated Skills" provision, trial-run inspections at construction sites, including public and private development works, continue in 2016.

During the trial runs, inspectors are not only able to collect data on the industry's compliance situation, they are also able to give on-site briefings to workers and site management to enhance their understanding of "Designated Workers for Designated Skills" and their legal liabilities.

From 1 January to 22 March 2016, the inspection team conducted 10 trial-run inspections at construction sites for various types of work. Seven sites involved government or public works and three involved the private sector,

encompassing a total of 247 workers.

Contractors are welcome to participate in the trials to provide valuable data to draft the relevant Codes of Practice and implement "Designated Workers for Designated Skills". For details, please contact the Workers Registration Secretariat at 2100 9266.

Training Initiatives For Workers

The CIC continues to provide the 1-year Basic Craft Courses (BC), Adult Short Courses, and in-house courses on of Enhanced Construction Manpower Training Scheme (ECMTS), i.e. courses trades with manpower shortage, for the training of workers for the construction industry in addition to the provision of Construction Supervisor/Technician Training Programme (CST) and Enhanced Construction Supervisor/Technician Training Scheme (ECSTS) for the training of supervisors and technicians. Furthermore, it also collaborates with main contractors, sub-contractors, industry associations and trade and labour unions to provide various cooperative training schemes.

By the end of February 2016, a total of 199 and 347 trainees graduated, respectively, from the Adult Short Courses and in-house courses of Enhanced Construction Manpower Training Scheme (ECMTS), i.e. courses on trades with manpower shortage, while 140 completed the training of the cooperative training schemes. The cumulative training figures of in-house courses of Enhanced Construction Manpower Training Scheme (ECMTS), i.e. courses on trades with training of the cooperative training schemes. Applications for Trade Tests subsequent to the Enactment of Construction Workers Registration (Amendment) Ordinance

The CIC continued its efforts in promoting trade tests and the arrangement of "senior workers registration" to tie in with the enactment of the Construction Workers Registration (Amendment) Ordinance 2014 in April 2015. Tabulated below are the respective cumulative number of applications for trade tests and senior workers registration arrangement, which showed a sustained uptrend, as of end February 2016:

Update Of Advanced Construction Manpower Training Scheme - Pilot Scheme (ACMTS-Pilot)

Since the launch of the aforesaid Scheme comprising ACMTS-Pilot (Structured On-the-Job) in the form of collaborative training provided by contractors and sub-contractors and ACMTS-Pilot (Skills Enhancement Courses) conducted by labour unions to train skilled workers for the industry in September 2015, a total of 278 applications and 138 applications, respectively, have been received as at 29 February 2016.

Contractor Cooperative Training Scheme-Crawler Crane Operation (Apprenticeship) Course In view of the difficulties facing contractors in joining the Contractor Cooperative Training Scheme - Crawler Crane Operation Course, like the lack of a designated warehouse for training and insufficient intakes of trainees, the Construction Industry Training Board agreed to the introduction of a new training mode of having 1 trainee guided by 1 trainer in construction sites under the Contractor Cooperative Training Scheme - Crawler Crane Operation (Apprenticeship) Course. The Course will be a 52-day training programme with 10 days being allocated for Safety and Theoretical Training, 39 days for Practical Training and three days for the Certification Test. Trainees will be allowed to operate the crawler cranes in designated timeslots, either in the early morning or in late afternoon, with the site area being fenced off as a temporary training ground. As such, trainees will have around 60 hours of hands-on experience in operating crawler cranes and be better prepared for the certification test at the end of the course.
