Committee on Construction Safety

Safety Alert No. 001/14 on Fire Safety on Construction Sites Published

The CIC released a new Safety Alert No. 001/14 *Fire Safety on Construction Sites* on 17 April 2014. This Safety Alert is aimed at reminding various parties on fire safety in construction sites or renovation projects.



The Safety Alert recommends the following: proper storage of dangerous goods; good site housekeeping practices; implement a "permit-to-work system" for hot work, such as welding; regular checks of electrical installations and electrical portable tools to ensure they meet the safety standards; and the installation of appropriate fire service equipment, including fixed fire pumps, fixed electrical installations, and portable fire extinguishers.

Technical Visit to Construction Sites in Guangzhou

Following on from the first meeting of the Task Group on Preventing Fall Accidents through Building Design and the Task Group on Preventing Fall Accidents in Existing Buildings on 7 January 2014 and the subsequent safety conference entitled "RMAA Safety Conference" organised by the Labour Department and

the Occupational Safety and Health Council (OSHC) held on 17 February 2014, it was proposed to arrange a site visit in Mainland China.



The Com-CSY then arranged a technical site visit on 25 March 2014 in Guangzhou. Members of the Com-CSY and members of the two task groups under the Task Force on Work Safety on RMAA Sites were invited to join the visit to see first hand the safety experience and practices of two construction projects in Mainland China. The two construction sites belonged to Sun Hung Kai & Company Limited and China Vanke Company Limited. Participants exchanged knowledge on the safety management system, scaffolding safety, site housekeeping, working at height, workers' welfare and healthcare during the visit. The visit was of great interest and members sincerely thanked the two companies for their hospitality.

Benchmarking Study on Infrastructure Projects Safety in Korea

The Com-CSY Chairman, Mr. CHEUNG Hau-wai, with the Committee members Mr. CHOW Luen-kiu and Mr. Victor KWONG and Ms. Sally LEUNG, Manager - Council Services, participated in the Benchmarking Study on Infrastructure Projects Safety in Korea organised by the Occupational Safety and Health Council (OSHC) and Korea Occupational Safety and Health Agency (KOSHA) from 17 – 21 March 2014.

The study tour comprised a series of theoretical studies, site visits as well as practical aspects. Participants learnt about Korea's Construction Health and Safety Policy, Safety Management System, Prevention Strategies against Occupational Injuries, Risk Assessment, Working at Height, Lifting Operations and Electrical Safety. Participants visited a tunnel construction, the Ulsan Harbour Bridge as well as a Safety Innovation School. More experiences were shared by the Com-CSY Chairman in the Korea Infrastructure Safety Forum organised by the OSHC on 22 May 2014.

CIC Innovation Award

To recognise the contribution of academics and industry practitioners in developing initiatives for practical use in the construction industry in Hong Kong and to promote continuous enhancement and sustainability in the industry, the CIC will organise its inaugural Innovation Award.

The Innovation Award will be divided into two categories, namely the Category for Academia, which is open to academics holding a full-time appointment or currently studying in institutions offering higher

education in Hong Kong, and the Category for Industry Practitioners.

All entries should focus on three subject fields: construction materials, construction methods or construction technology. Entries will be assessed on the level of innovation and originality, impact and applicability. Apart from the first and second place prize, a Young Innovator Award has been set up to encourage creations from academics or practitioners below the age of 40.

Committee on Procurement and Subcontracting

The Committee on Procurement and Subcontracting met at the end of May to deliberate on its new tasks and the way forward. In the pipeline are the following publications led by different task forces which are being prepared for publication later this year.

Fact Sheet on Owner-Controlled Insurance Programme

With the concerted efforts of members of the Task Force on Employer-Procured Insurance Policies in Construction Contracts, the first draft of the Fact Sheet on Owner-Controlled Insurance Programme (OCIP) in Construction Contracts has been completed. It will go through the proper approval process before issuance. The fact sheet will provide industry stakeholders with general information on the application of OCIP in construction contracts.

Procurement Alert on Use of On-Demand Performance Bonds

The Special Group on On-Demand Bonds has

completed drafting a Procurement Alert on the Use of On-Demand Performance Bonds in Construction Contracts to recommend a number of good practices relating to the use of on-demand bonds in construction contracts, and to remind the industry's stakeholders to act in a responsible and appropriate manner when implementing on-demand bonds.

FAQs Document on NEC3 Collaborative Contracts

Led by the Task Force on NEC3 Collaborative Contracts, the drafting of a Frequently Asked Questions (FAQs) Document on NEC3 Collaborative Contracts is underway. All comments from members have been incorporated. The Chairman and section leaders of the Task Group on NEC3 Collaborative Contracts are working on the supplementary inputs received from the ICAC to raise the awareness of industry practitioners on the corruption risks in NEC contracts as well as the preventive measures. The FAQs Document will be finalised after incorporation of this input.

Reference Materials on the Selection of Consultants

Another round of circulation to gather members'

comments has been completed. The Chairman of the Task Force on the Selection of Consultants and Contractors is reviewing the consolidated comments from members on the revised draft before finalising the Reference Materials on the Selection of Consultants.

Action Taken Against Registered Subcontractors

A hearing of regulatory actions by the Management Committee of the Subcontractors Registration System (SRS) was conducted on 26 March 2014 involving six registered subcontractors all related to late payment of MPF contributions for their employees. Sanctions ranging from a written warning to suspension of registration for six-months were taken against the registered subcontractors by the Management

Committee after having considered the circumstances of each case.

In this hearing, the Management Committee also deliberated on for the first time the regulatory action taken against registered subcontractors for civil court judgment in connection with their violation of the relevant section(s) of the MPF legislation.

New Task Force on Enhancements to SRS

The nomination of members for the new Task Force on Enhancements to SRS from key employers, trade and labour unions was completed in April 2014 and the first meeting of the Task Force was scheduled for 19 May 2014 to deliberate on its work plan.

Committee on Productivity and Research

Hong Kong Construction Industry Performance Report 2012

The Construction Industry Council has published the *Hong Kong Construction Industry Performance Report for 2012*. The report provides an overview of the performance of Hong Kong's construction industry in terms of productivity, health and safety, manpower, and dispute resolution over the past 12 years from 2001 to 2012.



This is the second construction industry performance report compiled by the CIC. The report identifies an improvement in health and safety with a decreasing trend in the rate of industrial accidents over the past 12

years. It also notes an increasing contribution from the construction industry to Hong Kong's gross domestic product (GDP).

In addition, the report shows that the Hong Kong construction industry is facing an ageing problem although the retention rate of graduates for the CIC's basic craft courses and construction supervisor / technician programme has been improving.

The number of construction related court cases registered at the High Court Registry had been decreasing gradually from 2003 to 2009. A rebound happened in 2010, while the number decreased again in recent years.

New CIC Research Journal *iCON*

The CIC published its inaugural issue of its research journal *Innovation in Construction (iCON)* in the second quarter of 2014 to advocate innovation and disseminate valuable outcomes generated from the CIC's funded research projects. The journal is planned to be published on a bi-annual basis with special feature articles.

The inaugural issue features the Carbon Labelling Scheme for Construction Products, and presents the findings of the six awarded research projects. *iCON* is anticipated to play a significant role in sharing views, ideas and knowledge among various industry stakeholders and the research community.

Construction Workers Registration Board

Sub-committee on Registration Matters

In response to stakeholders' views, the CIC has streamlined the procedure of adding new designated trades for registration under the *Construction Workers Registration Ordinance* (Cap. 583). Relevant information can be found on the CIC's website. In addition, workers applying for registration renewal are no longer required to hand in their current or expired registration cards to the CIC in exchange for the new registration cards.

Task Force on CWRS

To address stakeholders' concerns about the new Construction Workers Registration System (CWRS), some possible solutions have been identified to improve the system to cater to the specific needs of the construction industry. In addition, the new construction worker registration card, which is currently under development, will be able to store and display information of other construction-related cards / certificates issued by other authorities in an attempt to reduce the number of cards that a worker would need to carry.

Further briefing sessions to update the industry on the latest design of the CWRS will be carried out prior to the finalisation of its development.

Sub-committee on Senior Workers Assessment

The Sub-committee on Senior Workers Assessment has been actively taking part in the discussion on senior workers' registration arrangements with a view to establishing an efficient assessment mechanism to attract and encourage qualified workers to register as skilled workers of related trades.

Task Force on Reviewing the Outflow of Construction Workers

The task force, which has recently been set up, has identified three target groups of workers with potential for joining or rejoining the construction industry. They are (1) valid registered workers without construction site attendance records over the past year; (2) workers with expired registration; and (3) CIC graduates who do not engage in the construction industry.

The task force will conduct telephone surveys to find out reasons or incentives that could entice them back to the industry. A series of focus groups will be organised to help CIC graduates look for relevant employment opportunities in the construction industry with a view to increasing the supply of local construction workers.



ZCB Hosts Inaugural Ambassador Scheme Annual Reception

The CIC and ZCB hosted the inaugural ZCB Ambassador Scheme Annual Reception at ZCB on 23 April 2014. The Annual Reception appointed new ZCB Student Ambassadors and commended the current ones for their efforts in practicing and promoting the low carbon lifestyle message throughout 2013. ZCB also took this opportunity to express thanks to all Professional Ambassadors for their significant contributions during ZCB training and activities.

The Commander of the ZCB Ambassadors, Mr. Paul CHAN, Secretary for Development, who made the opening speech, said he was committed to leading fellow ambassadors to spread the ZCB message of low carbon and sustainable living to the community.



With a year of promotion, nearly 1,000 students had enrolled in the ZCB Student Ambassador Scheme, which aims at empowering young people with skills, knowledge and confidence in environmental protection, and motivating them to take control of

their own carbon footprint in order to help make changes at home, at school and in society to build a low carbon community together.

ZCB Exhibits at Macao International Environmental Co-operation Forum and Exhibition 2014

ZCB exhibited for the first time at the Macao International Environmental Co-operation Forum and Exhibition (MIECF 2014) which took place at The Venetian Macao – Resort – Hotel Expo Hall from 27 to 29 March 2014. ZCB not only showcased its zero / low carbon building design and cutting edge technologies, but also used the forum to develop its



network with green-tech experts and share news on the latest industry trends and technologies.

The three-day event attracted 9,245 visitors with almost 400 exhibitors from 20 countries. Mr. WONG Kam-sing, Secretary for the Environment, paid a visit to ZCB's booth and took the opportunity to promote low carbon living concept to the public.

In order to reduce environmental waste, ZCB reused previous exhibition items which shown at the Low Carbon Guangzhou Fair 2013. The booth was made by environmentally friendly materials and was previously exhibited at Eco-Asia Expo held in Hong Kong. This earned ZCB a Merit Award of the "Green Booth Award and Electricity Fee Rebate Programme" organised by MIECF 2014.

ZCB Earns "The Best of Eco-life – My Favorite Green Building" Award

ZCB has received "The Best of Eco-life – My Favorite Green Building" Award organised by *U Magazine* in recognition of its contributions to promoting the low carbon lifestyle concept and to encouraging the public to reduce its carbon footprint. The award was nominated and voted on by the public, indicating that awareness of leading a low carbon lifestyle is gradually increasing.

Mr. YU Wai-wai, Chairman of Zero Carbon Building Limited received the award and took the opportunity to not only thank the public for its support, but also invited more people to visit ZCB to learn about and experience the low carbon technology in Hong Kong.

Energising Kowloon East Project Talk for Ambassadors

ZCB has been very successful in recruiting almost 1,000 secondary and tertiary students to be ZCB Student Ambassadors in the past year. Starting from this spring ZCB is organising various talks for ambassadors to enhance their knowledge of low carbon building, technologies and construction.

The first talk in 2014 was held on 17 May at the Energising Kowloon East Office. Mr. Xavier YAM, Works Consolidation Manager of the Development Bureau, gave a talk on the Energising Kowloon East Project and its related green features. After the talk, the ambassadors joined a guided tour inside the Energising Kowloon East Office, one of the BEAM Plus Platinum Rating green buildings.

The activity was welcomed by the Student Ambassadors and they expressed interest in joining future activities.



ZCB Receives Certificate of Merit from 2013 Hong Kong Awards for Environmental Excellence

ZCB received a Certificate of Merit in the Green Innovations Awards of the 2013 Hong Kong Awards for Environmental Excellence from among 28 entries in recognition of its commitment to innovation in low carbon technology and the promotion of low carbon living to the public.

The Green Innovations Awards Scheme aims to encourage local organisations to meet environmental challenges with new ideas that will benefit the environment. All entries were assessed rigorously in terms of "level of innovation", "environmental achievements and cost-effectiveness", and "replicability and contribution to society" by professionals.



Construction Industry Training Board

Update of Manpower Situation

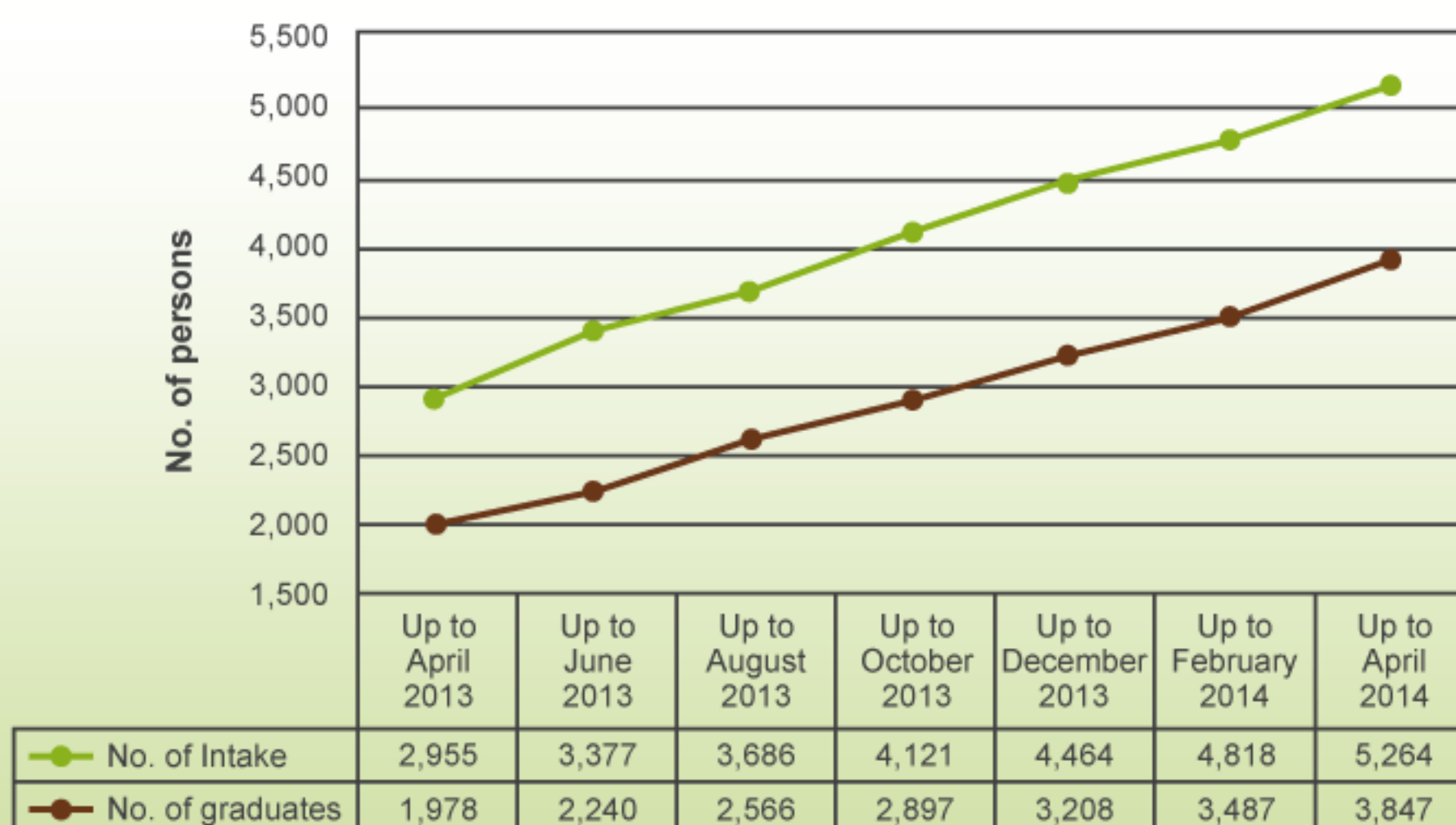
The first update of the Construction Industry Council Manpower Forecasting (CICMF) Model will be uploaded onto the CIC website for the information of the public. The result of the second update of the CICMF Model which will cover workers, site supervisors, technicians and professionals in the construction industry is being considered.

Training Initiatives for Workers

The CIC has approved 5,282 'in-house' worker training places for various trades in 2014. Taking historical recruitment and drop-out rate of trainees into account, it is expected that the projected training output would be about 5,200 (about 4,200 graduates and 1,000 trainees under training) by the end of 2014.

Since the beginning of collaborative training in 2011 up to April 2014, the Construction Industry Training Board has approved 2,532 collaborative training places. The intake is 1,304 to date. Only 569 trainees completed training. It is necessary that contractors are to be encouraged to participate in collaborative training schemes namely Contractor Cooperative Training Scheme, Subcontractor Cooperative Training Scheme, Plumbing-Contractor Cooperative Training Scheme and Contractor Cooperative Training Scheme for E&M trades.

CIC Graduates Available for Employment

Starting from August 2013, emails are sent out on a monthly basis to prospective employers including contractors, subcontractors and construction associations announcing the number of CIC graduates available for employment. New Jobs on JobsNet

As at the end of April 2014, there are 822 employers and 20,203 job seekers registered at JobsNet. New job postings in March and April 2014 have increased moderately as compared to that in January and February 2014, mainly contributed by around 10% of the registered employers. More efforts are required in encouraging employers to make use of JobsNet for recruitment purpose. Detailed figures are shown in the following table:

On-the-job Training Subsidy Scheme

Under this scheme, a subsidy ranging from \$4,000 to \$6,000 per month is given to participating employers of graduates of the Enhance Construction Manpower Training Scheme, Contractor Cooperative Training Scheme, Subcontractor Cooperative Training Scheme, and Plumbing-Contractor Cooperative Training Scheme. Subsequent to its recent launch in late 2013, a total of 13 applications have been approved to subsidise 40 trainees to receive on-the-job training in construction scaffolding works, surveying and setting-out, site surveying, marble polishing, and welding. A number of applications involving five new trades on painting, timber formwork, bar-bending and fixing, metal works, and metal formwork to provide 38 training places are also received and being processed.

CIC Tin Shui Wai Training Ground Replacement Identified

As the CIC Tin Shui Wai Training Ground will be returned to the Government by the end of 2014, two plots of land have been identified with the assistance of the related Bureau suitable for use as outdoor training grounds. These two plots of land are at Tin Yuet Road in Tin Shui Wai and Kai Fuk Road in Kowloon Bay. Tender invitation to set up the two lots will be issued soon and training is expected to start four to five months after taking over the sites.

Introduction of a Safety Training Re-validation Course for Construction Workers of Specified Trade – Tunnel Worker

This re-validation course will be offered in the second quarter of 2014 for those tunnel workers whose completion certificates of three-year validity of the Safety Training Courses for Construction Workers of Specified Trade are going to expire. The course fee will be \$110 with a class size of 30 trainees.
