





## New Repair, Maintenance, Alteration and Addition (RMAA) Intermediate Tradesman Collaborative Training Schemes and Certificate Programmes



With a view to increasing the supply of skilled workers, the Development Bureau has issued the Technical Circular (Works) No. 6/2019 on the implementation of mandatory construction industry collaborative training schemes (CICTS) in public works contracts under the Intermediate Tradesman Collaborative Training Scheme (ITCTS) administered by the Construction Industry Council (CIC). The technical circular recognises participation in ITCTS for fulfilling the mandatory requirements on worker training for their public contracts.

To better equip for the current needs of the market, CIC is pleased to announce the launch of two new ITCTSs:



Repair, Maintenance, Alterations and Additions (Building Construction)

Repair, Maintenance, Alterations and Additions (Electrical and Mechanical)

Both of them can fulfil the existing required training quotas for public works and help equip the trainees in the growing Repair, Maintenance, Alterations and Additions (RMAA) market. The two new schemes not only focus on developing the multi-trade skills required within the RMAA industry, such as wet and dry trades, plastering, painting, plumbing, E&M works and more, but also include an enhanced safety awareness course and customer services training. CIC is proud to have developed these new multi-trade schemes and hopes to elevate the quality of works in our trainees.

CIC in parallel has developed two full-time certificate programmes (the "Programmes") as an alternative to the above ITCTSs, namely the Certificate in Repair, Maintenance, Alteration and Addition (Building Construction) and Certificate in Repair, Maintenance, Alteration and Addition (Electrical and Mechanical). The above 90 days and 95 days programmes respectively are in line with the ITCTSs where the graduates will also be equipped with enhanced safety awareness and customer services as well. Through these Programmes, the graduates will be able to handle all general matters required by the RMAA industry and can be valuable assets to contractor companies looking for multi-trade individuals to handle RMAA matters.
