To Meet the Manpower Demand of the Industry CICTA Launches Two New Skill Enhancement Courses

Hong Kong • 2 March 2012 – Following the success of the Appreciation Courses on Conservation of Built Heritage - Painting, Carpentry & Joinery, the Construction Industry Council Training Academy (CICTA) is ready to launch the "Appreciation Course on Conservation of Built Heritage (Brick Wall, Plastering and Tiles)". This course is intended for qualified tradesmen who have obtained Full Certificate in Bricklaying, Plastering and Tiling. The first class will be commenced on 12 March in Kwai Chung Training Centre of the CICTA. Three hours per class and 18 hours in total, the tuition fee is HKD360. This course consists of the following contents:

- Common plastering workpieces of Chinese and British built heritage in Hong Kong and their characteristics; the basic concepts of repairing built heritage; the procedures of repair works for the plastering workpieces and the principles of historical relics protection
- 2. Appreciation and demonstration on the repair of various brick walls, plastering and tiles of the built heritage
- 3. Technical assessment

The CICTA will also launch the "Technically Competent Person T1 (Minor Works) Training Course" to provide training for supervisors without specified qualification of registered minor works contractors (Class I) and to make them qualified as Technically Competent Person T1 (Minor Works).

This course is intended for the in-service site supervisors of minor works and those who have at least five years of relevant construction site supervisory experience in minor works. The first class will be offered in the middle of March in Kowloon Bay Training Centre of the CICTA. Three hours per class

and 63 hours in total, the tuition fee is HKD3,500. This course consists of the

following two modules:

1. Construction Safety and Quality Supervision: Code of practice for site

supervision; the responsibilities and duties of Technically Competent

Person T1 (Minor Works); site safety supervision; demolition works,

addition and alteration works; quality supervision; etc.

2. Construction Management: Laws and contracts; administration, planning,

human resources and project management, supervision and coordination

of construction works; corruption prevention; safety management and

regulations, etc.
