The CIC's Greater Bay Area Forum 2019 Explores Opportunities for the Construction Industry

Hong Kong • 14 May 2019 – The Construction Industry Council (CIC) today organised the CIC Greater Bay Area Forum 2019. Mr. Ivan FU, Member of the CIC and Chairperson of the Steering Group on Greater Bay Area (the Steering Group), Ir Albert CHENG, Executive Director of the CIC together with Ir KAN Jun, Managing Director of China Road and Bridge Corporation (Hong Kong / Macau), Dr. Morgan YANG, Vice President, Transport Infrastructure, China, AECOM and Mr. Rex WONG, Executive Director and Chief Executive Officer of Kum Shing Group spoke at the Forum. Two Members of the Steering Group, Sr Dr. Stephen LAI and Ir PAN Shujie, jointly acted as Facilitators for the floor discussion.

Through the Forum, he hoped to further enhance the understanding of the industry practitioners on the GBA initiatives and urge the industry to grab the opportunity to take part in the GBA development, such as infrastructure, project management as well as the Electrical and Mechanical related projects.

Looking forward, the CIC is committed to contributing efforts to the development of the GBA initiatives, fostering collaborations among the stakeholders and providing continued support for the GBA implementation in various aspects, with a view to building capacity, offering advisory services and accelerating the digitalisation of the construction industry.
