# "Construction Industry Caring Campaign - Fight against Novel Coronavirus" Extending the Beneficiary Coverage of Workers

Hong Kong • 23 March 2020 – The novel coronavirus is raging throughout Hong Kong, the Construction Industry Council (CIC) has been joining hands with the industry to launch the "Construction Industry Caring Campaign - Fight against Novel Coronavirus" (Campaign) to provide monetary support to construction workers inflicted by the epidemic as well as caring support to their families. The Campaign's Management Committee decided to extend the beneficiary coverage to seven trades of registered licenses recognised by governmental departments and public bodies with effect from today. New beneficiaries include:

- Registered Electrical Workers under the Electrical and Mechanical Services Department (EMSD);
- 2. Registered Lift Workers under EMSD;
- 3. Registered Escalator Workers under EMSD;
- 4. Registered Gas Installers under EMSD;
- 5. Licensed Plumbers under the Water Supplies Department;
- 6. Registered Fire Service Installation Contractors (Individual) Class 3 under the Fire Services Department; and
- 7. Registered Minor Works Contractors (Individual) Class III under the Buildings Department

(Remark: For workers who receive the compulsory quarantine for arrivals from the Mainland on or after 17 February 2020 are not eligible for the scheme.)



Mr. CHEUNG Wing-ho, Chairman of The Federation of Hong Kong Electrical & Mechanical Industry Trades Unions said, "In response to novel coronavirus, the construction industry unites and be strong, launching the Construction Industry Caring Campaign – Fight against Novel Coronavirus, and one of the tasks is to provide allowance to workers who placed in compulsory quarantine. Electrical and Mechanical Services industry is one of the branches in the construction industry and a trade at an advanced stage in construction projects, some of the workers from property maintenance and repair are not necessarily required to work at construction sites, therefore they may not apply for workers registration card. I am glad to hear that the Campaign extends its beneficiary coverage to seven trades with registered licenses recognised by governmental departments and public bodies. It is a recognition and it shows supports to them. I hope all construction workers perform their duties diligently and fight the virus. Together we can win."

In addition, the Campaign also provides caring support to successful applicants and their immediate families, including (a) to make caring calls; (b) to purchase and deliver basic necessities; (c) to coordinate industry care resources; (d) to send "Caring Pack"; and (e) referral to social groups and professional services. **Applications and relevant documents could be submitted to 9764 1945 through WhatsApp and WeChat.**
