| 1.4 | CIC/CSY/P/001/18 (for discussion) | <p>Proposed Subcommittees to be formed under Com-CSY</p> <p>To enhance the work effectiveness of Com-CSY, the Chairperson proposed to form three Subcommittees under Com-CSY to handle certain amount of existing and future assignments of different nature. The proposed Subcommittees were “Subcommittee on Safety Promotion”, “Subcommittee on Safety Training” and “Subcommittee on Safety Technical Issues”. The composition of subcommittee should include a chairperson (from Com-CSY members) and eight to ten members.</p> <p>After deliberation, members agreed to set up the three subcommittees under Com-CSY. It was also agreed to disband the four existing Task Forces, i.e. “Task Force on safety of Bamboo Scaffolds”, “Task Force on Site Safety of Working in Lift Shaft”, “Task Force on Safety of Lorry-mounted Cranes” and “Task Force on Safety Experience Training Centre” upon their completion of assigned tasks. The “Task Force on Work Safety of Repair, Maintenance, Alterations and Additions (RMAA)” would be preserved while the function of the “Task Force on Site Safety Incidents” would be taken over by the “Subcommittee on Safety Technical Issues”.</p> <p>[Post Meeting Notes: An email was sent on 1 June 2018 to invite Com-CSY members to indicate their preference to participate in the three subcommittees.]</p> |

After deliberation, members agreed to set up the Task Force and suggested to invite representatives from RMAA works related associations, i.e. Contractor's Authorised Signatory Association (CASA) and Registered Minor Works Contractors Signatory Association (RMWCSA). |
| 1.6 | CIC/CSY/P/0103/18 (for discussion) | Proposed 3-Year Strategic Plan, 2019 Work Plan and Budget With the establishment of the three subcommittees in 2018, the 3-year strategic plan, targeted to achieve the following aspects, would be discussed further subsequent to the establishment of the three subcommittees: (a) Safety Promotion – to develop and execute safety promotion activities and to explore the opportunities to organise safety collaboration promotion schemes with relevant stakeholders. (b) Safety Training – to work closely with the Centre for Professional Development (CPD) of the Hong Kong Institute of Construction (HKIC) and other relevant stakeholders as a platform for gap analysis and evaluation between courses provided by CPD and the expectation from the industry as well as the latest construction site and legal requirements. Provide feedback and recommendations to CPD for safety training review and strategic development purposes. (c) Safety Technical Issues – to review technical aspects of safety, and to implement practical initiatives to improve safety. Such initiatives including design for safety, review of cause of accidents, issuances of alerts, review of existing practices, introduction of good practices and guidelines, and monitor of related research projects or application of new technology. |

| | | <p>Jointly organised by the Development Bureau (DEVB) and CIC, Construction Safety Week (CSW) 2018 was successfully held from 21 to 29 May 2018. Key items were highlighted as follows:</p> <p>New initiatives for this year:</p> <ul style="list-style-type: none">(a) Safety Video Competition – attracted nearly 100 entries and over 5,700 people voted for the most popular video; and(b) Safety Sharing Session in Construction Sites – nearly 40 construction sites participated <p>Other activities:</p> <ul style="list-style-type: none">(a) Qi Gong Train-the-trainers and Refresher courses in May – over 200 people enrolled(b) Conference on 21 May – over 500 people attended(c) Innovative Safety Initiative Award – attracted over 120 entries(d) Site Visits on 24 May – arranged 10 exemplary sites with over 300 people enrolled(e) Carnival on 27 May – attracted over 7,000 people participated(f) CCSAS on 29 May – attracted over 300 construction sites participated and over 900 people attended the ceremony. |
