Note: (1) Candidates **must first pass the written test (inclusive of Wire/Cable Color Identification Test) before applying the practical test.** Wire/Cable color identification test is conducted in form of written test. Subject to prior approval from the HKCITTC, and when needed, written test attendants can bring and wear their own vision-aided eyeglasses during the Wire/Cable Color Identification Test. To apply for such arrangement, please write to the HKCITTC when you enrol for the written test.

- (2) Candidate must apply for and pass the practical test within 3 years starting from the passing day of written test. Upon passing both parts of written test and practical test, candidates will be issued a "Trade Test Certificate for Grade A Electrical Work".
- (3) Candidates who failed the test is required to re-apply for the test and pay the relevant application fees. Each candidate is allowed to attempt the written test and practical test for no more than 4 attempts in every calendar year (Scheduling subject to the actual circumstances).
- (4) Availability of these tests may be subject to interruption due to, but not limited to, equipment/facility maintenance and adverse weather condition. The courses including the admission of applications may be suspended due to the above mentioned incidents without prior notice. To confirm course availability, please contact us at 2100 9000.

- The test fees listed may be reviewed and adjusted by the CIC if necessary without prior notice.
- Candidates who have passed the written test (inclusive of Wire/Cable Color Identification Test) and practical test will be issued a "Trade Test Certificate for Grade A Electrical Work".
- Trade Test Certificate for Grade A Electrical Work" is not equivalent to the " Certificate of Registration of Electrical Worker" issued by the Electrical and Mechanical Services Department. For details, please visit the website of Electrical and Mechanical Services Department (www.emsd.gov.hk) or contact the Electrical and Mechanical Services Department.
- Applicants who are not Hong Kong Permanent Residents, please attach the copy of valid working permit issued by the Hong Kong Immigration Department.
- Applicants who reach the age of 65, please call Hong Kong Construction Industry Trade Testing Centre 2100 9000 for checking the trades that may be required to submit medical examination reports issued by Registered Medical Practitioners and acquiring the standard forms of reports
- Candidates may request to postpone the trade test by submitting his reasons in writing. Such letters must reach CIC at least 3 working days before the scheduled testing day. If the reason is accepted by the HKCITTC, the candidate can reschedule 1 time for free
- CIC reserves all rights to amend trade test arrangement, including but not limited to accept any test/ course application and/ or change the relevant clauses in a timely manner without giving any reasons or explanations, and CIC will not accept any liability in respect of claims for expenses or other damages. Notice for candidates:
- Candidates must show their valid Construction Industry Safety Training Certificate (Green Card) and wear suitable work wear including safety shoes; otherwise, (1) you will not be able to attend the practical test and be treated as an absence.



(2)Candidates who arrive late are not allowed to enter the examination room will be treated as an absence and need to apply again, Note (2) (on next page) are satisfied. Application

- Applicants can enroll via the mobile application ("TTOA"). Upon approval of application, the applicants could settle the related payment via ATM / by Cheque / by bank (1) transfer OR at 7-Eleven by presenting the barcode given in the TTOA.
 - Complete the application form together with a cheque or bank draft for the test fee payable to "Construction Industry Council".
- (3) A photocopy of the applicant's Hong Kong ID Card and "Construction Industry Safety Training Course Certificate" (Green Card) must be affixed on the application form. The copy will be destroyed once the information of the applicant has been verified
- (4)Applicants must submit a copy of proof of work experience with company's stamp and signed by person-in-charge, as mentioned in Part (C) overleaf.
- Send the completed application form, supporting document (Point 4 of above) and together with a cheque or bank draft to the Hong Kong Construction Industry Trade Testing Centre, 38/F, COS Centre, 56 Tsun Yip Street Kwun Tong, Kowloon (5)
- All trade test fees are non-refundable and non-transferrable. Candidates who want to withdraw from the tests have to submit their reasons in writing to the CIC at least 3 working days before the schedule test date. An administration fee amounting to 20% of the paid test fee will be charged. Special consideration will be given to (6) candidates who request to withdraw because of prolonged injury.
